STIPULATION TO CONSOLIDATE APPEALS

IT IS HEREBY STIPULATED AND AGREED, by and between the parties

the above-captioned appeal be consolidated for all purposes with:

1 (1) Sumona Islam, Appellant, vs. Golden Road Motor Inn, Inc., dba
2 Atlantis Casino Resort Spa, Respondent, Supreme Court Case No. 64452; and

3 (2) MEI-GSR Holdings LLC d/b/a Grand Sierra Resort, Appellant, v.
4 Golden Road Motor Inn, Inc., a Nevada Corporation d/b/a Atlantis Casino Resort
5 Spa, Respondent, Supreme Court Case No. 65497.

6 This stipulation is entered into for purposes of judicial economy and in the
7 interests of justice in that Case Nos. 64349, 64452 and 65497 involve appeals from
8 the same district court case, the same parties and the same counsel for the parties.

9 IT IS FURTHER STIPULATED AND AGREED that the three cases be
10 consolidated under the lowest case number and all further pleadings and papers
11 bear the captions of the three appeals, with the caption for Case No. 64349 listed
12 first, Case No. 64452 listed second, and Case No. 65497 listed third.

13 IT IS FURTHER STIPULATED AND AGREED that the following briefing
14 schedule be instituted and adopted:


- 15 o Opening brief of appellant Atlantis Casino Resort Spa and joint appendix

25 answering briefs (Atlantis Casino Resort Spa's reply brief will contain
26 its answering brief on Grand Sierra Resort's appeal regarding
27 attorney's fees and costs)




