



ORDER REGARDING TRANSCRIPTS

Appellant's counsel has filed a motion for an extension of time to file the fast track statement and appendix, in which counsel informs this court that the transcripts requested from court recorder Janie Olsen have not yet been received.¹ To date, Ms. Olsen has not filed the notice of delivery required by NRAP 3C(d)(3)(E)(ii). Ms. Olsen shall have 14 days from the date of this order to (1) file the requested transcripts in the district court and deliver the transcripts to counsel, if she has not already done so, and (2) file a notice of delivery with the clerk of this court in compliance with NRAP 3C(d)(3)(E)(ii).² If Ms. Olsen requires additional time to prepare the requested transcripts, she shall file and serve an appropriate motion in this court within the same time frame. Failure to

comply with this order may result in the imposition of sanctions. See
NRAP 3C(n); NRAP 13.


