

WRIT OF PROHIBITION

TO: The Honorable Elizabeth Goff Gonzalez, Judge of the Eighth  
Judicial District Court:

WHEREAS, this Court having made and filed its written decision  
that a writ of prohibition issue,

NOW, THEREFORE, you are instructed to vacate from your March  
16, 2015, order the sanction that was made payable to the Sedona  
Conference and to reallocate the total \$250,000 sanction in compliance  
with RPC 6.1(e). You are also instructed to vacate from your May 28, 2015,  
order the determinations that Sands China is subject to personal  
jurisdiction under general and transient jurisdiction theories; you are  
further instructed to prohibit Steven Jacobs from introducing evidence at  
trial that pertains solely to those theories. Finally, you are instructed to  
vacate your June 19, 2015, order in which you directed Sands China's  
Independent Director to appear for a deposition in Hawaii. The above  
instructions all pertain to the case entitled Steven C. Jacobs vs. Las Vegas  
Sands Corp., A Nevada corporation; Sands China Ltd., a Cayman Islands  
corporation; Does I through X; and Roe Corporations I through X, Case  
No. A627691.
