ORDER

On July 27, 2015, this court entered an order transferring all documents filed in Docket No. 68394 to this appeal and directing that the writ petition filed in Docket No. 68394 be treated as the opening brief in the instant appeal. Our order further instructed that appellant may supplement the record on or before August 11, 2015. On August 7, 2015, appellant was granted an extension, until August 25, 2015, to supplement the record. On August 24, 2015, appellant filed, via E-flex, a supplemental brief in excess of 50 pages and a supplemental appendix in excess of 400 pages. Respondents Betty Hamilton, Michael William Moreno, and Bob Borgersen have filed a motion to strike the supplemental brief and appendix and for sanctions.

Cause appearing, we grant the motion, in part. The clerk of this court shall strike the supplemental brief filed, via E-flex, on August 24, 2015. This court's July 27, 2015, order granted appellant leave to supplement the record, not to file what essentially amounts to a second

opening brief. Respondents' motion for sanctions is denied. We remind respondents that the answering brief remains due by August 26, 2015. We further remind appellant that she shall have 10 days from service of the answering brief to file and serve a reply brief, if deemed necessary. No extensions of time will be granted in regard to the filing of the reply brief.

The Nevada Judges of Limited Jurisdiction (NJLJ) have filed a motion seeking leave to file a brief of amicus curiae. Respondents oppose the motion and the NJLJ have filed a reply. Cause appearing, the motion is granted. NRAP 29(c). The clerk of this court shall file the brief of amicus curiae received on August 10, 2015. Respondents shall have until September 9, 2015, to file any response to the NJLJ's brief of amicus curiae. No extensions of time will be granted in regard to the filing of a response to the brief of amicus curiae.

It is so ORDERED.
