Brief description of nature of the action:

This is a dispute between plaintiff LV Sun and Stephens Media, as owner and publisher of the Las Vegas Review Journal ("Review Journal"), over the calculation and distribution of profits under a Joint Operating Agreement, as amended and restated in 2005 ("JOA"). The LV Sun alleges that the Review Journal has miscalculated annual profit payments to the Sun under the JOA by treating its editorial costs as a cost of doing business to arrive at profit available for distribution to the Sun under the agreement.

Profit from operations under the JOA is determined annually under Appendix D to the Agreement. If there is a disagreement between the parties over profit and its calculation, Appendix D to the JOA stipulates that the disagreement shall be resolved in arbitration by a certified public accountant in accordance with "the commercial arbitration rules of the American Arbitration Association." The Sun, however, contends that the dispute is a legal dispute involving the meaning of § 4.2 of the JOA, which does not address the Sun's compensation or its calculation of profit on annual basis.

Proceedings and result in the district court:

This lawsuit was initiated by the Sun under a complaint that triggered the arbitration clause because the Sun sought "a proper calculation of EBITDA ("earnings before interest, taxes, depreciation and amortization") and payment of all [outstanding] Annual Profits Payment obligations," which the Sun alleged to be at least \$6,000,000, plus interest, since the JOA went into effect in 2005. The District Court, in response to Stephens Media's motion to compel arbitration, ordered the parties to arbitration. At the same time, however, the Court encouraged the Sun to file an amended complaint that on its face would not invoke arbitration. The Sun then filed its First Amended Complaint seeking only declaratory relief as to the "meaning" of section 4.2 and "the obligations it places on the Parties' performance" of the JOA.

According to the Sun, section 4.2 of the JOA prohibits Stephens Media from considering its editorial costs as an expense of doing business to arrive at EBITDA to compute profits and allocation of profits to the Sun in accordance with Appendix D to the JOA. Stephens Media responded to the Amended Complaint with a Renewed Motion to Compel Arbitration, which the District Court denied.

Stephens Media is appealing from the August 19, 2015 order of the district court that denies its Renewed Motion to Compel Arbitration.

- Mr. Morris stated that there is a dispute over compensation, referencing Appendix D which contains an arbitration clause. The Sun is requesting the Court to step into the shoes of the arbitrator and rule as a matter of law that editorial costs not be considered for tax and compensation purposes. Mr. Reid argued this is a renewed motion to compel arbitration and the arguments do not meet the rehearing standard under the law. The Court has ruled that the amended complaint does not implicate the arbitration provision and their motion should be denied. COURT FINDS that the declaratory relief claim as stated in the First Amended Complaint does not invoke the arbitration provision and ORDERED, Motion DENIED. Mr. Morris requested a STAY pending an appeal. COURT ORDERED, STAY GRANTED. Court stated it would not order a bond for five days; if the Notice of Appeal is not filed within five days, the stay will be dissolved; after five days, if counsel believes there is an issue requiring a bond, counsel is to file an appropriate motion.
