1 **POINTS AND AUTHORITIES** 2 Time for Serving and Filing Briefs. 3 The appellant shall serve and file the OPENING brief within one hundred and twenty (120) days after the date on which the appeal is 4 docketed in the Supreme Court. The respondent shall serve and file 5 his answering brief within thirty (30) days after service of the brief of the appellant. After service of respondent's brief, any OPENING brief must be served and filed within thirty (30) days. . . . By written 6 stipulation timely filed with the Supreme Court, the parties may 7 extend the time for filing any brief for a total of thirty (30) additional days unless the court otherwise orders. Applications for 8 extensions of time beyond that to which the parties are permitted to stipulate are not favored, and will be considered only on motion for 9 good cause clearly shown, or ex parte in cases of extreme and unforeseeable emergency. The Supreme Court may shorten the 10 periods prescribed above for serving and filing briefs, either by rule for all cases or for classes of cases, or by order for specific cases." 11 Mr. Harris' Opening Brief is currently due on June 1, 2016.
