

## MEMORANDUM OF POINTS AND AUTHORITIES

2 Respondents Helen Quan Lopez et al. are certain the Court is already aware 3 of the importance of both the underlying action and this appeal, and that a timely resolution of the issues involved is in the interest of all concerned. That is the 4 reason, of course, that Respondents have sought consolidation of the preliminary 5 injunction motion with trial on the merits, in order to allow final resolution of these 6 7 important questions in the shortest time possible. Appellant has rejected that 8 approach numerous times. As a result, this matter is likely to take significantly 9 longer to reach full resolution, even as Appellant moves for expedited briefing and 10 argument on appeal.

inappropriate Appellant 11 It is. further. entirely for present to extensive argument on the merits of this matter in order to make a simple request 12 13 for expedition. Respondents will not engage in that improper practice, and will 14 instead merely state their agreement to the proposed schedule, or indeed to any other 15 schedule this Court sees fit to order.
