*ORDER GRANTING MOTION TO ASSOCIATE COUNSEL AND
DENYING MOTION TO SUPPLEMENT RECORD*

Petitioners have filed a motion to associate Massachusetts attorney Alan Morton Dershowitz as counsel in this matter. Attached to the motion are a verified application, a certificate of good standing from the Commonwealth of Massachusetts, and a State Bar of Nevada SCR 42 statement. The SCR 42 statement indicates that Mr. Dershowitz has applied once to appear in Nevada courts in the last three years. See SCR 42(6)(a) (stating that repeated appearances by any person or firm pursuant to this rule shall be cause for denial of a motion). We grant the motion.¹ Mr. Dershowitz shall therefore be allowed to appear in this matter on behalf of petitioners. Nevada attorney Steve Morris of Morris Law Group shall be responsible for all matters presented by Mr. Dershowitz in this matter. SCR 42(14) (providing that the active member of the State Bar of Nevada who is the attorney of record shall be present at all matters in open court); NRAP 25(a)(5) (providing that all documents submitted to the supreme court for filing by a represented party shall

include the original signature of at least one attorney of record who is an active member of the State Bar of Nevada).
