

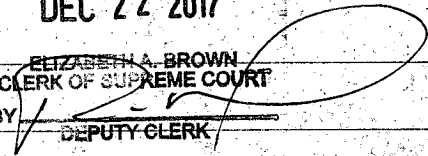

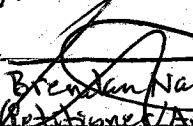
1 29, 2017, this Court Denied Appellant's Petition For Review.

7 CONCLUSION.

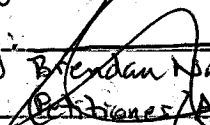
8 Wherefore, Appellant respectfully request this Court grant this mot-

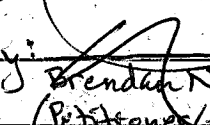
