Α When did you stop working at Bally's? 18 Q April 2011. 19 Α Why did you stop working at Bally's? 20 Q 21 Α Because I was fired. 22 When did you start working at Sbarro? 23 I started working at Sbarro's May. May the 9th, Α 24 Monte Carlo, Sbarro's Pizza Place at the eatery. 25 May of what year?

A May 2011.

- Q Okay. And did you work there for a long time?
- A Yeah, for about -- yeah, long time. A good while. It was a 24-hour pizza place, so I got some hours in.
- Q Okay. So did -- could it have been December of 2011 that Victoria spoke to police?
 - A Yes.
- Q How did you find out that Victoria had spoken to the police?
- A I was coming home about 2:00 o'clock in the morning from making pizza, working at the pizza shop, and Mahlica was telling me the police came and questioning everybody in the house. Yeah.
- Q Victoria wasn't living there at the time; right?

 Was she staying with Rose?
 - A She was staying with -- well, she was living there at the time, and then she started staying with Miss Rose.
 - Q Okay. Now, you said Mahlica told you at 2:00 o'clock in the morning that the police had been there. You didn't talk to the police right away, did you?
 - A No, I didn't. Because they were gone -- they were gone. By the time I made it home they were gone.
 - Q All right. But it was a few days before you talked to them; correct?

Q Yes. My question specifically is did you ever have an allegation or a complaint made by someone else against you that you would go out at night and leave your younger children in the care of your oldest daughter, Victoria?

A No. It was TT Pat -- Patricia, a friend of mine, that would come to the house. Because I was working at the lounge late. She would come to the house and see about them.

Q Okay. And I understand you're explaining who was watching them. But my question specifically is did you ever have a complaint made against you that you were leaving your children unattended or that they were being attended by

Victoria? 2 No, I don't remember that. Okay. Are you familiar with the Department of 3 Q Social Services in Louisiana? 4 5 Α Yes. 6 Q Okay. But I never met them, I never seen them in 7 Α 8 Louisiana. MS. LUZAICH: Well, objection. Can we approach? (Bench conference)

THE COURT: All four lawyers are present. Ms. Luzaich, go ahead.

MS. LUZAICH: You can't refresh her recollection with a document that she's never seen. What she's saying is that she was never approached. If somebody calls and makes a

complaint, that's just speculation.

THE COURT: There might be another way. I mean, she hasn't said -- well, first of all you have to say, do you need your memory refresh, and then you say, is there something that will refresh your recollection?

MR. MacARTHUR: Any document can actually be used for refreshing recollection. The critical question is whether or not it jogs her memory. Now, if she reads it and say, I don't remember this ever having happened, I can't read it into the record. One, it's not evidence, and, two, it didn't refresh her recollection. But you can use -- I could write a stickie note random words if it refreshes your recollection.

THE COURT: You can say, will this stickie note refresh your recollection, so whatever it is that you have you can say, well, would reviewing the transcript, the preliminary -- whatever --

MR. MacARTHUR: That's what I said.

What I will now say is intended to serve as an introduction to the trial of this case. It is not a substitute for the detailed instructions on the law which I will give you at the close of the case and before you retire to consider your verdict.

This is a criminal case commenced by the State of Nevada, which I may sometimes refer to as the State, against the defendant.

The case is based on the information. The clerk will now read the information to the ladies and gentlemen of the jury, and she will state the plea of the defendant to the information.

THE CLERK: Thank you, Your Honor.

(Information read)

THE COURT: Thank you, Susan.

This case is based upon an information which just has been read to you by the clerk of the Court. You should distinctly understand that the information is simply a charge and that it is not in any sense evidence of the allegations it contains.

The defendant has entered a plea of not guilty to the information. The State therefore has the burden of proving each of the essential elements as alleged in the charging document by proof beyond a reasonable doubt. As the

defendant sits here today he is presumed innocent. The purpose of this trial is to determine whether the State of Nevada will meet their burden of proof.

It is your primary responsibility as jurors to find and determine the facts. Under our system of criminal procedure you are the sole judge of the facts. You are to determine the facts from the testimony you hear and the other evidence, including exhibits introduced in court. It is up to you to determine the inferences which you feel may be properly drawn from the evidence.

The parties may sometimes present objections to some of the testimony or other evidence. It is the duty of a lawyer to object to the evidence which he or she believes may not properly be offered, and you should not be prejudiced in any way against a lawyer who makes objections on behalf of the party he or she represents.

At times I may sustain objections or direct that you disregard certain testimony or exhibits. You must not consider any evidence to which an objection has been sustained or which I have instructed you to disregard.

Anything you may have seen or heard outside the courtroom is not evidence and must also be disregarded.

Remember statements, arguments, and opinions of counsel are not evidence in the case. However, if the attorneys stipulate as to the existence of a fact, you must

accept the stipulation as evidence and regard that fact as proved.

You must not speculate to be true any insinuation suggested by a question asked a witness. A question is not evidence and may be considered only as it supplies meaning to the answer.

You must not be influenced in any degree by any personal feeling of sympathy for or prejudice against the State or the defendant. Both sides are entitled to the same fair and impartial consideration.

In considering the weight and value of the testimony of any witnesses you may take into consideration the appearance, attitude, and behavior of the witness, the interest of the witness in the outcome of the case, if any, the relation of the witness to the defendant or the State, the inclination of the witness to speak truthfully or not, and the probability or improbability of the witness's statements and all the facts and circumstances in evidence. Thus, you may give the testimony of any witness just such weight and value as you believe the testimony of the witness is entitled to receive.

There are two kinds of evidence, direct and circumstantial. Direct evidence is testimony by a witness about what that witness personally saw or heard or did. Circumstantial evidence is testimony or exhibits which are

proof of a particular fact from which, if proven, you may infer the existence of a second fact.

You may consider both direct and circumstantial evidence in deciding this case. The law permits you to give equal weight to both, but it is for you to decide how much weight to give to any evidence.

Opening statements and closing arguments of the attorneys are intended to help you in understanding the evidence and applying the law, but they are not evidence.

No statement, ruling, remark, or comment which I make during the course of this trial is intended to indicate my opinion as to how you should decide the case or to influence in any way in your determination of facts. At times I may even ask questions of witnesses. If I do so, it is for the purpose of bringing out matters which I feel should be brought and not in any way to indicate my opinion about the facts or to indicate the weight I feel you should give to the testimony of the witness.

I may also find it necessary to admonish the lawyers, and if I do, you should not show prejudice against a lawyer or his or her client because I found it necessary to admonish him or her.

Until this case is submitted to you you must not discuss it with anyone, even with your fellow jurors. After it is submitted to you you must discuss it only in the jury

room with your fellow jurors. It is important that you keep an open mind and not decide any issue in the case until the entire case has been submitted to you under instructions from myself.

I may during the trial take notes of the witnesses' testimony. You are not to make any inference from that action. I'm required to prepare for legal arguments of counsel during this trial, and for that reason I may take notes.

The jury will not have a transcript to consult at the close of the case. However, you have been furnished with note pads and pencils. You will be permitted to take notes. You will also be permitted to take those notes with you when you go back to deliberate upon your verdict.

Has the jury been provided with note pads?

Okay. We're going to hand you out note pads and pens. You are permitted to take notes. I always like to make it clear when you go back to deliberate upon your verdict you will not have a transcript of the proceedings. However, you will have notes that each of you take, and you'll obviously have your memory. So during deliberation it will be your memory and your notes that will prevail.

When you get these notebooks I just ask that you put your name in the front, because I don't let you take them out of the courtroom until you go back to deliberate upon your

verdict. So at the end of the day the court marshal will be under Court order to collect all your notebooks, but them in a safe place, and when you return the next morning they will be there waiting for you.

The trial will proceed in the following manner. The Deputy District Attorney will make an opening statement, which is an outline to help you understand what the State expects to prove. Next the defense attorney may, but does not have to, make an opening statement. Opening statements are not serve as an introduction to the evidence which the party making the statement intends to prove.

The State will then present its evidence, and counsel for the defense may cross-examine the witnesses.

Following the State's case the defendant may present evidence, and the Deputy District Attorney may cross-examine the witnesses. However, as I have said, the defendant is not obligated to present any evidence.

After all of the evidence has been presented I will instruct you on the law. After the instructions on the law have been read to you each side has the opportunity to present oral argument. What is said in closing argument is not evidence. The arguments are designed to summarize and interpret the evidence. Since the State has the burden of proving the defendant guilty by proof beyond a reasonable doubt, the State has the right to open and close the

arguments.

After the arguments have been completed you will then retire to deliberate upon your verdict. Again let me remind you that until this case is submitted do not talk to each other about it or about anyone who has anything to do with it until the end of the case when you go to the jury room to decide upon your verdict.

Do not talk with anyone else about this case or about anyone who has anything to do with it until the trial has ended and you've been discharged as jurors. "Anyone else" includes members of your family and your friends. You may tell that them you're a juror in a criminal case, but don't tell them anything else about it until after you've been discharged by myself.

Do not let anyone talk to you about the case or about anyone who has anything to do with it. If someone should try to talk to you, please report that to me immediately by contacting the court marshal.

Do not read any news stories or articles or listen to any radio or television reports about the case or about anyone who has anything to do with it.

As jurors in the case you do have the right to ask written questions of any of the witnesses who are called to testify in this matter. You are not encouraged to ask large numbers of questions, because that is the primary

responsibility of counsel.

Questions may be asked, but only in the following manner. After both lawyers have finished questioning the witness and only at this time if there are additional questions you would like to ask the witness, you may then seek permission to ask that witness a written question. Should you desire to ask a question, write your question down with your juror number on a full sheet of clean paper and raise your hand. All questions from jurors must be factual in nature and designed to clarify information already presented. In addition, jurors must not place undue weight on the responses to their questions.

The court marshal will pick up your question and present it to the Court. All questions must be directed to the witness and not to the lawyers or to myself. After consulting with counsel I will then determine if your question is legally proper. If I determine that your question may properly be asked, I will ask the witness the question. No adverse inference should be drawn if the Court does not allow a particular question.

At this time I'm going to ask that the notebooks be passed out. In the notebooks the preliminary instructions that I gave to you are in there, the admonishment that I give you before we recess every time, I am required by law to read that admonishment to you, also the instruction on how to ask

questions of witnesses, that's also in there if you need to refer to that. And in the back are blank note paper in which you may take notes. I know this case is going to go longer than normally, so if you need any additional paper, just let me know, and we'll make sure that you get that. These are your juror notebooks. If you open up the left side, in that pocket, you can pull that out, that's the only thing that you can take out and keep with you. It just tells you where you are and the phone numbers to my chambers so if for any reason you need to get in touch with us you have those numbers and you can get in touch with us.

But, again, I just want to make sure you understand those notebooks are not permitted to leave the courtroom at any time. They will be here every time you leave, and they'll be here in the morning. And you will be able to take those notebooks with you when you go back to deliberate upon your verdict.

At the end of the case when I do give you the instructions on the law everyone will have a copy of the jury instructions. You will also be able to put that, the jury instructions, in your notebook.

With that, the State of Nevada may address the jury panel in your opening statement.

STATE'S OPENING STATEMENT

MS. LUZAICH: Mark Twain once said that truth is stranger than fiction. By the end of this trial you will absolutely understand what he meant. This trial over the course of the next week is about that man, Frederick Harris, and his control of and manipulation of the Duke children.

about her oldest daughter, Victoria, who is today 21; her daughter Mahlica, who is today 20; her son Shabazz, who is today 19; her daughter Taharah, who is today 14; and her daughter Taquanda, who is today 13. You're going to hear all the way back to when Tina had her first child, Victoria, was living in Ohio, went to Louisiana, where she had the rest of her children. Tina was living with the father of her children. He was an individual who was potentially not like you or I and did not believe in schooling for the children. So you are going to hear that until the kids came here to Nevada they were not schooled.

In December of 2004 Tina came here to Nevada from Louisiana. Previously she had gotten away from the kids' father, so she and her children were living in Louisiana. They had been what she will call travellers. They didn't have a permanent home. But when she got away from him she was working at bar in Louisiana called Faces. And while she was working there in 2004 she met the defendant. Although he was

living in Las Vegas, he had been for a period of time in New Orleans or in Louisiana, met Tina.

You're going to hear some things about Tina that may make your skin crawl over the last -- over the next week.

Remember, it is the defendant who is on trial, not Tina. You don't have to like her, you're probably going to hate her, but you're going to hear all sorts of crazy things about her.

You're going to hear first that after she met the defendant Tina came to Las Vegas to visit with him and did not bring her children. At the time Victoria was eleven, Mahlica was ten, Shabazz was nine, Taharah and Taquanda were about four or five.

After she had been here for a little while the defendant sent his brother to Louisiana to bring Tina's kids here. They had lived in a shelter or some sort of place for a little while, but then they began to live with a lady that you will hear them call Miss Ann. Miss Ann's name is also Lealer Ann Cooks. He, the defendant he, was involved with Miss Ann. He was also involved with Tina at the time.

The kids and Tina lived with Miss Ann, and eventually Tina found a job, so she was actually working here for a period of time into 2005. Miss Ann was also working, and the defendant was working. The defendant lived in an apartment. You're going to hear about one day that the kids went to the defendant's apartment while Tina was at work and

while at the apartment, while the other kids were either sleeping or outside or doing something else, the defendant brought Victoria, who at the time was 11, into his room. And while in his room he took her hand and he put it on his genital area. He then put his finger in her vagina. He then put his penis in her vagina. Afterwards he told her, don't tell anyone or I will beat you.

Victoria, however, told. She told Miss Ann. Miss Ann told the defendant's mother, and they yelled at Victoria. They didn't believe her. They treated her badly after that. They told her mother, and the description Tina heard Tina also didn't believe Victoria. Victoria was treated, she'll describe for you, very badly, differently. She was sort of separated from the other kids after that.

And then you're going to hear about how in May of 2005 Tina took her five children and went to Utah. You're going to hear that Tina was pregnant, she couldn't have another child, she already had five she could barely take care of, if at all, and she gave that child up for adoption. There was an agency in Utah that relocated her to Utah, her and her children, and she did give that child up for adoption.

You're also going to hear that while she was in Utah with those kids she decided to come down here to visit Fred, the defendant. I think it was his birthday, I don't remember what the incident was. And she may have been here a little

longer than anticipated. When she got back to Utah CPS, or at least the Utah equivalent of our CPS, had taken her children. So her children were placed in foster care in early 2005. Victoria and Mahlica were in one home, Taharah and Taquanda were in another home, and Shabazz was in another home. Tina had to work through a program in Utah whereupon she was able to get her children back. She did continue to see the defendant, however.

In August of 2007, after they'd been there for about two years, the kids will describe for you that one night Mom woke them up, put them in Fred's car, and drove them back to Las Vegas. Now, the kids liked it in Utah. It was a small town, people were friendly there. But, nope. They were woken up, they were put in his car and brought to Las Vegas.

Now, when Fred, the defendant, brought them to Las Vegas in August of 2007 he brought Mahlica, Shabazz, Taharah, and Taquanda to a house at 966 Blankenship. You'll hear that in the time that the Duke family was in Utah Miss Ann and the defendant moved into a house together on Blankenship. Prior to the family going to Utah Miss Ann had lived in a place on Trish Lane, and she's got a daughter. You're going to hear she had lived there, as well. But while the family was in Utah the two of them had acquired a house, 966 Blankenship. You're going to hear lots about that house.

So the defendant brings the family back, but he only

takes, like I said, Mahlica, Shabazz, Taharah, and Taquanda to the house. He tells those kids that Victoria's a bad influence on them, and he separates Victoria from them. Не takes Victoria and Tina to his mother's for a short time and then to a -- what Tina will describe as an efficiency apartment, kind of like the Siegel Suites. The kids while in Utah finally were going to school. So when they came back here to the Blankenship house the defendant did enroll them in school. Victoria, while she was living in this other location with her mom, also went to school. But you're going to hear about how in the middle of August, while the kids were at the Blankenship house and Tina and Victoria were not at the Blankenship house, that one night the defendant tells them, hey, let's go for a ride. And he has Tina in front and Victoria in the back, and he stops and he gets some alcohol. And he drives around a little bit, and he gives Victoria some alcohol. Victoria has literally just turned 15. The end of July of 2007 Victoria turned 15. This is August of 2007. Не gives Victoria some alcohol and he says that he's going to take her virginity.

So he drives the car up to someplace that is going to be described as Sunrise Mountain, that while there Tina is in the front seat, the defendant gets in the backseat with Victoria. She's been drinking by now. And he does in fact have sex with her. Against her will, she doesn't want to, she

indicates she doesn't want to, he puts his penis in her vagina. Tina is in the front seat, you're going to hear. Tina does nothing. Tina actually watches. Tina is also drinking at the time, but she does nothing to stop it. In fact, you'll hear Victoria say that she thought her mom was somewhat amused by it.

Eventually Tina and her mom move into, like I said, the Siegel Suites -- not Tina and her mom, sorry, Tina and Victoria, and then into an apartment on Walnut. You're going to hear while they lived at the Siegel Suites apartment that the defendant would come over and he would have sex with Victoria on a fairly regular basis. He would also have sex with Tina on a fairly regular basis. Meanwhile, Miss Ann has the other kids at the Blankenship house.

Now, the defendant is living at the Blankenship house. He's just coming over and having sex with Victoria, he's coming over and having sex with Tina. You're going to hear from Tina that the defendant would tell her that she's not giving him enough money, he's got her kids, he's taking care of her kids and he wants more money. She had by then gotten a job at Bally's. She was working at Bally's as a maid. But that wasn't paying enough for him, so he told her she needed to go make some more money faster. And she'll tell you how she was forced by him to work the streets to exchange sex for money and that she was required to give him, the

defendant, the money that she made on the streets. He would threaten her, I'm going to put your kids out, they're going to not have a roof over their head; but also by now he had gotten heavy handed and violent. He had threatened to hurt her and beat her, and there were occasions that he did hurt Tina. And she'll tell you that this is why she did this. She'll even describe for you that there was one night that he wanted more money, it was a slow night, she didn't have any, girls were getting arrested. He was so angry that she didn't have any money he called her a stupid whore, he threw her down, and he forced his penis in her butt.

Now, she will tell you clearly there were occasions that she had consensual sex with him absolutely. There were occasions after that, but this particular violent night he forced his penis in her butt. That was not a consensual act. He yelled at her, he beat her, and he forced her on that night.

You're going to hear that during the time that they were at the Walnut apartment not only did the defendant have sex with Victoria on a regular basis, he would put his penis in her vagina, he would put his penis in her butt, he also brought toys over. You're going to hear from Victoria about how he would also put vibrator or dildos in her vagina. He had separated her from her siblings, her mom was out working, either at Bally's or working the streets. There was not

anything Victoria could do.

You're going to hear also during this time frame -so by now we're into 2007-2008 -- the kids, Mahlica, Shabazz,
Taharah, and Taquanda, are living at the house with Miss Ann.
You're going to hear from them while this was going on at
Walnut and the Siegel Suites that the defendant is any more
pleasant at the Blankenship house. You're going to hear from
all of these kids about how the defendant would beat them with
a belt when they didn't do what he wanted. If they didn't do
the chores in exactly the same way, if they didn't have
something sitting properly or lined up properly, he would beat
them with a belt. You will hear occasions where they would -they will describe for you how it happened to them. They will
also describe for you how they saw him do it to their siblings
or heard it in another room.

You're going to hear not only about beatings with a belt and marks being left on body parts, you're going to hear that there was an occasion that the defendant threatens

Taquanda with a knife because she did something he didn't like in the kitchen.

You're going to hear there was an occasion that he choked Mahlica because she spoke back to him. You're going to hear that while all of this is going on there were occasions that the kids were able to go see Mom and Victoria, but it wasn't very often, and they were always there, either Miss Ann

or the defendant.

There did come a time, however, that the defendant moved Tina and Victoria into the house on Blankenship, somewhere around 2009. You'll hear that by then when the defendant would go to Victoria it was much fewer and farther between. You'll hear that there was some instances of sexual intercourse at the Blankenship house between him and Victoria, but not much.

You'll hear that eventually -- now, they lived there for probably a year, year and a half, give or take, and everyone's going to talk to you about time frames, and they're all slightly fuzzy on time frames. But you'll hear that there did come a time that Tina moved out of the Blankenship house with Victoria, Mahlica, and Shabazz, but she left Taharah and Taquanda behind. You're going to hear that there were -- sorry, that they had gotten a guardianship agreement. They actually went to an attorney, they got a piece of paper so that Tina gave guardianship of Taharah and Taquanda to Miss Ann, and then she moved out of the house.

And, I'm sorry, I have to go back. I said that there are things that you're going to hear about Tina that are going to make your skin crawl. One of those things that you're going to hear is that while they were at the Walnut apartment not only did the defendant have sex with Victoria, not only did the defendant have sex with Tina, but the

defendant made Tina and Victoria engage in sexual acts with each other. You're going to hear about Tina giving oral sex to Victoria, you're going to hear about a dildo that has two sides to it. You're going to hear about how the defendant caused Tina and Victoria to both sit on one end, one on the other end of this dildo while he watched and enjoyed.

So when Tina moved Victoria, Shabazz, and Mahlica out of the house on Blankenship she moved them to an apartment in North Las Vegas. They'll call it the St. Andrews apartment. I don't know if it was on St. Andrews Street or that's what the apartment was called, but that's how the family will refer to it, the St. Andrews apartment.

While at the St. Andrews apartment the defendant would continue to come, he would continue to have sex with Victoria, he would continue to have sex with Tina. By now Victoria is just about of age. I believe she's still 17, she may be turning 18. But this is the life she will describe to you that she has lived since she came back from Utah in August of 2007. She doesn't know anything else.

You'll hear also that Victoria met a lady named Rose Smith while she was living at the St. Andrews apartment, I believe Tina may have met her first, that Tina walked into a church-type location saying that she was -- she found this place, she needed money to get home, and a nice lady named Rose Smith and her what she calls her spiritual mother talked

to Tina and gave her a ride home. And that's how Rose Smith met the kids. And she became very close to Victoria. Rose, you'll hear, has a son who is a little bit older than Victoria, and has a daughter who is younger than Victoria. Interestingly, today, while Victoria is 21, Rose's daughter is 13. And the way Rose will describe Victoria to you is she may be chronologically a lot older than my daughter, but emotionally and mentally they're the same. You will see that through the course of this trial, that many kids are maybe not where you would expect to them to be at their chronological age emotional and mental level. Rose is very clear about that. Tina not so much, but Rose, the objective person, will be.

So Rose and Victoria became close. She would have the kids at her house, Victoria, Mahlica, Shabazz. She had not met Taharah and Taquanda. Victoria, Mahlica, and Shabazz would come to her house, have barbecues, things of that Rose will tell you how she lost track of Victoria for nature. a little while, that one day one of her kids saw Victoria and Victoria came back to the home and back to the family to By now Tina had moved Victoria, Shabazz, and Mahlica visit. to another apartment in Henderson on Center Street. going to hear that they still live there, and the rest of what you're going to hear about the family is when they lived on Center Street.

When they were at St. Andrews there were times that the defendant or Miss Ann would bring the kids to visit the family at St. Andrews, and there were times that they would bring them to visit at Center Street, as well. You're going to hear that the defendant continued to go to Center Street, that he would get money from Tina for the kids, that he would have sex with Tina, that he would have sex with Victoria at Center Street. What you will hear is that in December of 2011, while they were living at Center Street, this is when Rose and her family kind of caught back up with Victoria. Victoria was staying at Rose's house one night and they were having a conversation about being sacred. Rose is quite religious, you're going to hear. And Rose was talking to Victoria about being sacred, and Victoria said, well, you know, I can't save myself because Fred has already taken it from me. Rose was just shocked. And Victoria told Rose some of what had been going on with Fred over the course of the last few years. Rose was appalled.

Rose took Victoria right to the Henderson Police

Department. In fact, they get to the Henderson Police

Department somewhere around 11:30 at night. At the Henderson Police Department a detective from the Sexual Abuse Detail gets called out. The detective -- Detective Aguiar you'll hear from. He talks to Rose and he talks to Victoria. And Victoria explains for him what had happened back in 2005 when

she was 11, how she went to Utah, how she came back, and how since she came back from Utah she described for him in detail the time in the car on Sunrise Mountain, she described for him what was going on at the Siegel Suites, she described for him what was going on at Walnut, she described for him what was going on at Blankenship, she described for him what was going on at St. Andrews, and she described for him what was going on at Center Street.

She was also extremely concerned about Taharah and Taquanda, because they were living at house with him. They were living there and had access -- or he had access to them.

Now, she said, I haven't heard anything that he has touched them, I haven't heard that, but I am worried about them. So in the middle of the night, at 1:00 o'clock in the morning, three Henderson detectives went to 966 Blankenship to check to make sure Taharah and Taquanda were okay. So they bang on the door, they have Metro patrol with them, because, you know, detectives, plainclothes, 1:00 o'clock in the morning, who knows what's going to be inside. And Ann -- Miss Ann and Fred are home. They wake up, and the detectives interview everybody.

Now, you're going to hear that they talked to the defendant first. You're going to hear that the defendant initially denies any sex whatsoever with Victoria, what, who, me, no, no, no, I'm like a father to her. Ultimately,

however, you're going to hear that he admits that he had sex with Victoria, although he says he only had sex with Victoria after she turned 18. You're going to hear that he also admitted having sex with Tina. You're going to hear that he admitted having sex with Victoria and Tina.

After they talk to the defendant they talk to Miss Ann. Miss Ann maybe didn't know about the defendant having sex with Victoria and Tina. And you will hear that while two detectives were talking to Taharah and Taquanda -- and you'll hear that they talked to them separately so that they could get just what everybody knows on their own not contaminated by anybody else. But while two of the detectives were talking to Taharah and Taquanda, the third detective let the defendant and Miss Ann have conversation in the bedroom. And you will hear that there was an explosion in that bedroom.

So that night they talked to, like I said, Taharah and Taquanda. You'll hear that Taquanda did talk to the detectives about physical abuse that had been going on, the things that Fred and hit -- you know, belt and punch and things of that nature. But you'll hear that Taharah said, oh, no, no, everything is fine here, everything's fine.

So that night the detectives leave the house because there's no evidence of physical abuse, there's no evidence of sexual abuse in that home. What you're also going to hear about is when there are allegations of any kind of abuse in a

home involving children -- and at this point Taharah and Taquanda are about 10 and 11 or 11 and 12 -- Child Protective Services gets involved. By now Victoria is 18, so there's no Child Protective Services involved in what was going on with Victoria. But because Taharah and Taquanda are young, Child Protective Services gets called. You'll hear that the detective called the hotline, that's how things happen, and the hotline assigns a case to one of the workers.

You're going to hear that Bobbie Tibbs -- her real name is Teresa Tibbs, she goes by Bobbie -- Bobbie Tibbs contacts the kids and contacts the defendant and Miss Ann, as well, and there is an independent investigation. So Child Protective Services, through Bobbie Tibbs, is doing an investigation about what's going on in the Blankenship home.

And you'll hear that Bobbie Tibbs doesn't really hear anything from Taharah and Taquanda about, you know -- she doesn't hear anything about sexual abuse, and they don't really tell Bobbie anything. Unfortunately, if CPS does not have a disclosure, there's not much they can do. She had caused Fred, the defendant, to move out of the house while it was going on. Miss Ann and the defendant cooperated with Child Protective Services. You're not going to hear that he was difficult or anything like that. He cooperated. But you're going to hear that Henderson just kind of left it there. They didn't really do very much else at all.

Eventually Child Protective Services closes their case because they don't have any other information that anything inappropriate is going on at Blankenship. What you will hear, however, is that the defendant -- because by now he knows that Victoria is pretty much off limits because Victoria has disclosed to the police and there is still a pending police investigation, the defendant switches from Victoria to Taharah, who at the time is 11 and living in the home. What you're going to hear from Taharah is that the defendant sexually abused Taharah over the course of months, that it happened only in the Blankenship home, that it happened in his and Ann's room when Ann was not there, that it happened in Taharah's room, that it happened in the laundry room, that it happened in the garage. You're going to hear that he put his fingers in her vagina on several occasions, you're going to hear that he put his penis in her vagina on several occasions, you're going to hear that he rubbed her breasts, you're going to hear that he took her hand, put it on his penis, and made her hand rub up and down on his penis.

You're actually going to hear that one night

Taquanda saw something happen, that when the defendant got

Taharah out of the room that the two girls shared in the

Blankenship house Taquanda had woke up and she saw, either in

the mirror or something, she saw them walking down the hall

towards the laundry room. She's going to describe how she saw

Taharah's hand up on the wall, that she saw the defendant's hand on Taharah's hand, and that she heard a buckle. She's going to tell you how she knew that something inappropriate was going on. Taharah is older than Taquanda, so at this time Taquanda is 10 or 11, Taharah is 11 or 12.

You're going to hear that Taquanda asked Taharah about it and Taharah said, yeah, that he did that, that's what he did. On that occasion he put his finger in her vagina.

Not his penis, just his finger. Taharah doesn't really do anything. Taharah doesn't really tell anybody else.

Taquanda, however, goes and tells Miss Ann, says, hey, look at what your boyfriend's doing, he's sexually -- well, my words, sexually abusing -- he's touching Taharah, he's doing bad things to the Taharah. Miss Ann doesn't believe it. Taharah then does confirm that, yes, this has been happening. And Miss Ann actually takes Taharah to a doctor.

You're going to hear that Taharah went to a doctor, Dr. Gondy, that she had HPV. HPV, genital warts. You're going to hear that she told -- or that there was conversation with Dr. Gondy about sexual abuse, that she had an examination not only a vaginal exam, stirrups and whatnot, but also a vaginal ultrasound where something quite large is inserted in the vagina. She's 12 years old at the time. And she is given medication and things of that nature.

Miss Ann tells them that she's going to move them

out of the house, but she says, well, you know, just until then just lock the door or something, just lock the door, don't let him in. Well, she never actually does anything, and the abuse continues.

For the summer, you'll hear -- and it's May of 2012 that Taquanda tells Miss Ann. They go and spend most of the summer at Center Street with their mom and siblings. When they come back and school starts Miss Ann has still done nothing to protect Taharah, who was still being abused, so Taquanda one day finally, at the end of September, realizes that, well, I told a grownup and that grownup did nothing, we've talked to the police before. And so Taquanda, who has had communication with Child Protective Services before, called the hotline. Taquanda calls Child Protective Services on September 27th of 2012. The case is assigned to a worker, Sholeh Nourbakhsh, and you'll hear that in addition to CPS being involved in this, because it's going on in the home, Metro -- because Blankenship is in the Las Vegas Metropolitan Police Department jurisdiction, Metro also gets involved. So Detective Nick Madsen and Sholeh Nourbakhsh are now investigating what is going on between the defendant and Taharah.

Well, Detective Madsen, before Taharah is actually brought to what's called the Southern Nevada Childrens

Assessment Center to be interviewed, does a little research

and realizes that there has been an allegation before regarding the defendant involving Henderson Police Department, and he tries to contact Henderson so he can get that information. Unfortunately, it wasn't quite so easy. We find out that the Detective Aguiar that working the case left the Sexual Abuse Detail and went to Fraud. So Detective Madsen's trying to get that information. Sholeh from Child Protective Services actually goes to the school, gets the kids Taharah and Taquanda out of school, brings them to the Childrens Assessment Center so that they can be interviewed.

You're going to hear that the Southern Nevada
Childrens Assessment Center is a location where a bunch of
different agencies are all housed under one roof. There's
Sexual Abuse from Las Vegas Metropolitan Police Department,
there is Child Protective Services, the sexual abuse
investigators, there are forensic interviewers, people who all
they do is interview kids who have made sexual abuse
allegations, there are medical services. There's a doctor
there who has a clinic and sees kids there. There are
psychological services. All of this in one location, kind of
like one-stop shopping, so kids can come, they can be
interviewed, all these things in a friendly environment, and
they can do it all at once.

So you'll hear that the kids came on September 27th of 2012, they were interviewed, and they were examined by a

doctor. You're going to hear from Dr. Mehta that she examined Taharah, that she didn't find any physical evidence of anything, but she'll also explain to you way more than you've ever wanted to know about a young girl's vagina and why it is not unusual that, despite what she has described occurring, Taharah doesn't have physical evidence of it. The doctor will explain for you why that is not unusual and she is not in any way surprised.

Taharah does explain for the forensic interviewer while Detective Madsen and Sholeh watch the abuse that Fred has heaped on her over the last few months, the penis in the vagina, the fingers in the vagina, the rubbing his penis, the rubbing her breasts. And you'll hear that there's the investigations, that it took a while for the detective to actually get the information from Henderson, but ultimately he did, and here we are.

That, ladies and gentlemen, is the State's case in a nutshell. Over the course of the next week the State will present all of those witnesses that I have talked about to you. All I ask is that you pay attention. Because at the end of the trial, after you see and hear everything, you pay attention to everything that you have heard, you will find the defendant guilty of all the charges.

THE COURT: Thank you very much.

Opening, Mr. MacArthur?

MR. MacARTHUR: Thank you, Your Honor. DEFENDANT'S OPENING STATEMENT

MR. MacARTHUR: Good morning, ladies and gentlemen of the jury panel. I almost said prospective jury, because we spent two days finding you. This is opening statement, and I like to at the beginning explain how trial procedure works, because I find that the fewer surprises the better things tend to work out.

This is an opening statement. You've already heard the State's, and as soon as I'm done with this preamble, you'll hear from me. Then we'll have witnesses that testify. Each side will have an opportunity to examine them. After the State's case is completed they will close, and the defense will have an opportunity to present witnesses, if any. At the close of evidence you'll hear closing arguments. Now, what's important here is that the State will go first, then the defense goes, and, because the State has the burden, they get the last word. So they get to go twice at the end.

You'll see that there are two attorneys at each table. I'm with Betsy Allen for the defense, and it is my pleasure to be doing this trial with Betsy. This is our fifth together. But she is lead counsel, so this is going to be only time that you hear from me directly, other than when I question witnesses. So I want to make sure I do this right.

Opening statement, as described by the State, is

essentially our case in a nutshell. And there's an analogy that works pretty well, State versus the defense. You can think of the State's opening argument as using your GPS. If you do a lot --

MS. LUZAICH: I'm sorry. This is argument. Opening statement is really supposed to be just what is the evidence going to show.

THE COURT: Sustained.

MR. MacARTHUR: All right. The State has given you its version of the events that it believes the evidence will show. However, there are -- which should probably not be apparent to you yet, there are some significant gaps or lapses in the State's theory or explanation of what happened. And so I am going to present to you the timeline and the factors that the State either has not considered or refuses to consider.

Now, I appreciate the State having done some of my work for me. She identified some of the players to you. But just to make sure that I'm thorough, we have a couple of things. One, we have Tina Duke, the mother; we have her oldest daughter, Victoria Duke; we have her next daughter down, Mahlica Duke; her only son, Shabazz Duke; and her two youngest daughters, Taharah Duke and Taquanda Duke.

In the second household we have the defendant, Fred Harris. If I might --

Fred, stand up for me briefly.

Ladies and gentlemen, this is Fred Harris. We're going to be talking about him in graphic and abusive detail when it's the State's case, and we're going to be talking about him in different references when it's the defense case.

Mr. Harris, please have a seat.

The evidence will show you that he is more than a man sitting at a desk, quietly waiting for people to finish talking about him. The evidence is going to show you that he is retired from the phone company and that, at least at the time relevant in this case, he is also a contractor at the Nellis Air Force Base. He, during most relevant periods in this case, had a boyfriend-girlfriend relationship with another woman by the name of Lealer Cooks. She is also known as Ann. As a matter of fact, most of the children in the Duke family will refer to as Miss Ann.

Now, much of what I tell you, and it is going to agree with what the State said, and it should. The Duke family starts off in -- or at least for purposes of this case in Louisiana. This is 2004. The defendant has family in Louisiana, and he went to visit them in approximately July of 2004, whereupon he made the acquaintance of Tina Duke, who was working at the lounge described by the State. She was working as a cocktail waitress. They made pretty quick friends. They had a one-night stand, and they enjoyed each other's company enough to where they exchanged contact information, and he

invited her to contact him again if she ever happened to go out to Las Vegas.

Within six months Tina Duke did take an opportunity to visit him in Las Vegas. Without a lot of notice, although they did have contact with each other, she came out to Las Vegas and left her children in Louisiana. There may be some dispute as to whether she left them completely on their own or whether she left them in the care of someone else. However, when CPS investigated those circumstances they found that she had in the habit of leaving her children unattended and that her oldest daughter, Victoria, was typically left in charge, and that the oldest daughter was developmentally delayed and was expected to essentially act as an adult despite the fact that her development was equivalent of a young lady much younger.

Before CPS or its equivalent in Louisiana actually came and seized the children Tina Duke, having been in Las Vegas for a week, explained this predicament to Fred Harris, and Fred Harris contacted his brother, who is a over-the-road truck driver. That brother happened to be in Louisiana, and he asked the brother, in exchange for \$600, to bring the children out to Las Vegas. And that's exactly what happened. And so Louisiana's CPS was not directly involved in the case. The children were gone before their investigation began.

When the children arrived -- let me stop here and

say that clearly Fred Harris not their father. Fred Harris isn't even their stepfather. He was never married to Tina Duke, he was never in a committed relationship with Tina Duke. The defense is not going to deny that they had a sexual relationship ongoing over several periods of years and that they were friends and at times that they lived together. However, at no point should the evidence indicate that Fred Harris held himself out to the parents of these children, and I'm even going to go so far as to say that I expect that the testimony from the children would also reflect that.

These children's father is a man by the name of Marvin Gibson. The evidence will show that the reason that compelled Tina Duke to leave Louisiana the most was that this man was abusive. They had been transient, going from Louisiana to Texas or Florida, not necessarily in that order, I'm just listing the states, and that ultimately Tina Duke felt like she needed to get away from this man before he did something really bad to her family.

The children arrived in Las Vegas in January of 2005. The State said during its opening that Tina gained employment during the time she was in Las Vegas, but she didn't include any other details. Her employment at the time was actually in Larry's Villa, which, if you've lived in Las Vegas for a while, you know is one of our many strip joints. It's on Rancho and Bonanza. It's not one with the best

reputation.

Tina lived with her children with Lealer Cooks.

Lealer Cooks and Fred Harris did not live together at that time. They had an on-again-off-again relationship, but he would go to her house. It was not their custom for Lealer to go to his house. And so Tina and Lealer had Tina's children at that apartment for several months, which both parties, give or take, will estimate to be approximately May of 2005.

When Tina arrives in Las Vegas in January of 2005 she is pregnant. She may tell you that she knew she was pregnant, she may tell you that she did not know she was pregnant. Tina has a problem being consistent. Regardless of whether she knew when she arrived or not, this was not Fred Harris's child. She made arrangements through an agency in Utah to give her sixth child up for adoption. And when that process or that program was ready to begin she took all of her children, which was something of a surprise, she didn't explain that this was her intention to do so, and she went to Utah. This, again, would have been approximately May of 2005.

Now, the State brings up a relatively important point. There is an allegation that no one denies that Victoria was angry that her mother had left her in Louisiana and that at the same time, chronologically speaking, she said that she'd been inappropriately touched by Fred Harris. This was discussed between Lealer, Tina, and Fred Harris's mother.

The defense does not disagree with the State that Victoria was not believed. The authorities were not contacted. Tina relocated after the fact to Utah due to her pregnancy and the adoption.

While in Utah Tina continued to maintain contact with Fred Harris, and in December of -- Court's indulgence. In December of 2005 she comes back to Las Vegas to have a weekend or so with Fred Harris. The evidence will show that she came into a little bit of money and she wanted to spend it here recreating and have contact with Fred while she was here.

Unfortunately, Tina did not leave her children in anyone's care. The evidence will show that she had a neighbor that the children will refer to as Miss Heather, who she paid \$200 to to come in and check on the kids from time to time. When Miss Heather was not inside of that apartment, again, it was Victoria, the oldest and the developmentally delayed, that was responsible for her brothers and sisters. This is the second that that we are aware of in which she has been abandoned by her mother.

CPS is contacted by a concerned party. Tina is then contacted by CPS, saying, we have your children and you need to come back to Utah immediately. She does so. As the State explained in its opening argument, her children were placed in foster care, and she had to go through a parenting program in order to get them back. That took approximately six months.

Once she had them back, this would have been approximately August of 2006, she had them for one year where she lived in Utah working as a housekeeper and being, as far as we can tell, otherwise stable. However, she decided that she wanted to come back to Las Vegas because our casinos pay better than housekeeping opportunities in Utah. She returned, and when she did so she put her children in the household that was now occupied by Fred Harris and Lealer Ann Cooks.

So let's be clear about something. Evidence will show that Lealer Ann Cooks moved out of her apartment and into a house with Fred Harris and that this house is on 966 Blankenship in the west side of Las Vegas. However, Tina and her oldest daughter, Victoria, did not move into that house. And this will be an important point. Various witnesses will testify to you as to why it is that Tina and Victoria did not move in. But perhaps the most valuable testimony will be that of Tina herself. The evidence should show that the reason they didn't move in is because of the previous problem involving Victoria and the allegation made against Fred. Victoria will be described as boisterous, disobedient, undisciplined, and a bad influence on the other children. Не didn't want her in the house, there was no one that could force him to take her in the house, and so she lived with her mother in a hotel temporarily, for one month, and then they moved in with the defendant's mother at her house.

Incidentally, the woman from Utah that was watching the children, I believe she'll be referred to as Miss Heather.

Eventually Tina is working and is able to afford to move out on her own with Victoria. Now, this is another important point, because the State's case -- some of its charges involve pandering, and it will be explained to you later that that is essentially the legal way that we say pimping, when one person encourages, forces, or compels another person to act as a prostitute. The State's theory is that the defendant made her prostitute herself in order to provide money to care for her children. What the State does not mention in its opening argument, which should be something that you pay close attention to when it comes out, is that the defendant got Tina Duke a job at the Bally's doing housekeeping and that when she started there she was full time and getting between \$13 and \$15 an hour. The State, I assume, I have to make some guesses, is going to try to convince you that Tina Duke was working two jobs, one legitimate, one illegitimate, and forced to give all of her money to Fred Harris.

At this time CPS begins receiving complaints. Now, if you're not familiar with CPS, CPS is rather careful to protect the people who contact them as the complainers. They don't want to create situations where the person who calls in to CPS is then subject to some sort of revenge or backlash.

And so they will usually refer to the person who contacts them as the source. They don't disclose who that -- what that information is. At this point CPS begins getting a series of contacts from a given source that is not divulged. And these are recurrent, despite the fact that every time there's an investigation they come back unsubstantiated, it doesn't stop the complaints from coming in.

You later learn from the witnesses that these complaints were initiated by Victoria. However, as of October 2007 and summer 2008, which is where we are now, with the Duke children living with Lealer Cooks and Fred Harris in the Blankenship house and Tina and Victoria living in an apartment on a street known as Walnut in North Las Vegas, this is the time period in which the telephone calls start coming.

In April of 2008 the first allegation that there was sexual assault going on the State referred to in its opening argument the children were interviewed individually. Remember that at the Blankenship house are going to be Shabazz,

Mahlica, Taquanda, and Taharah. After interviewing each, each of them denies that there's any sort of sexual conduct going on or any sort of inappropriate touching. CPS closes the case in April of 2008 as unsubstantiated.

Now, the summer of 2008 Victoria Duke spends the summer with the defendant's mother, Miss Dorothy. When she finishes the summer she is permitted to move back inside of

the Blankenship residence. She would like to be closer to her brothers and sisters and her mother. Victoria and Tina are allowed to move into the Blankenship residence, and there are no allegations of abuse made by anyone between August of 2008 and May of 2009. It's important to note that at this time Victoria is between 16 and 17 years old.

For those of you taking notes, backing up earlier in my statement, the first sexual assault allegation that was made by not transmitted to law enforcement, that was somewhere between January and May of 2005. Back then Victoria was 12 years old.

Moving forward, Victoria, if she's consistent with other testimony she's given earlier in the case, is expected to say that her abuse at Blankenship resumes in May of 2009 and persists through August of 2010. Now, the reason I'm giving you these dates is that at some point you'll be asked to compare facts to criminal charges, and you'll recognize having heard this morning that sometimes it's sexual assault, victim under 14, sometimes it's sexual assault, victim under 16, and other times it's just sexual assault. And so in order to help organize this information I give you the dates so that you know where they correspond. The sexual allegations in this section are those that are without the age. Since Victoria's over the age of 16, these are the ones that are just sexual.

Now, the evidence will show that at this point
Victoria is undergoing psychotherapy. She also claims to have
exhausted her remedies, that she tried to tell her family and
that she was not believed, that she's tried to tell CPS and
that she wasn't believed. At this point she claims to have
told a Canyon Springs High School teacher, a mandatory
reporter, that she was being sexually assaulted. Ladies and
gentlemen, we have found that teacher, and we intend to have
her testify for you.

Next, Tina and Victoria move out of the Blankenship house in August of 2010. They move to an apartment on a street known as St. Andrews in North Las Vegas. And when Victoria leaves with Tina they take Mahlica and Shabazz with them. Prior to this point Mahlica and Shabazz have been living with Fred and Lealer, along with Taharah and Taquanda. Shabazz and Mahlica leave. Now with Lealer and Fred Harris there are Taquanda and Taharah. Taharah is the older of the two.

Tina, Victoria, Shabazz, and Mahlica remain at that address until October 26th, 2011. At that point they move to a residence in Henderson the defense believes is Center Street. You'll forgive us if we don't have any numbers. That should come out in testimony. At this point Victoria makes another allegation of sexual assault at the hands of Fred Harris. She contacts Henderson Police Department, as

described by the State's opening argument, and Henderson comes out immediately and in the early hours contacts everyone at the Blankenship house in order to obtain a statement.

At the time of that statement again the charges are unsubstantiated. CPS is also involved, because these are children.

And let me back up a step. Before Tina Duke and Victoria Duke move out of the Blankenship house Tina agrees to give temporary guardianship of Taharah and Taquanda to Lealer Cooks. She states her reasons for that were their further education, that they were stable, and that they were living well. She said that she trusted Fred and Lealer and she was confident that they had her best interests in mind. So when Tina and Victoria and Mahlica and Shabazz move out of the Blankenship address to St. Andrews they leave Taharah and Taquanda behind, which will become very important. Victoria is expected to testify that she does not like when her family is broken apart, that she misses her brothers and sisters, and she makes no secret that she can't stand Fred Harris.

During the contact from Henderson Police Department with the household we learn several things. And let me preface by saying that this is the worst thing about the defense's case. The police learned that Fred Harris has had sex with Victoria at the age of 19. The police think that sounds odd. And there's no reason that they wouldn't.

However, now that it's clear as to where Victoria's been living for the past several years the police step back a bit and ask for more corroboration. They start by talking to Tina. And Tina says, somewhat mystifyingly, that she is aware that her daughter had had sex with Fred and that she describes it as having been Victoria's idea. She denies it as having been forced upon her by Fred. She considered Victoria to be doing her own thing.

At this same time Victoria, who's no longer in the Blankenship address, she's living at St. Andrews with her mother, fails to complete the twelfth grade. This will become important later. Victoria also says that her abuse at the hands of Fred Harris -- because, remember, she maintains that it was abuse no matter what her mother said -- that there was less abuse at St. Andrews. She doesn't necessarily explain why, but that there was less abuse at the hands of Fred Harris at the St. Andrews address than at Blankenship or previous addresses.

At this point Victoria has already had the conversation described by the State with the big-hearted woman known as Rose. She's the religious woman that was talking about the importance of maintaining chastity. Now, something that Victoria appears not to have told Rose with regard to maintaining her virginity was that she is or if those two things did not overlap that she would soon be pregnant. That

child was not the child of Fred Harris. There's no allegation that it was the child of Fred Harris. I believe the evidence will show that that child miscarried. But she was unquestionably pregnant in February of 2012 when she was living at St. Andrews with her mother, Tina Duke.

The last part of the investigation by CPS, having been initiated by Henderson PD, into this sexual assault allegation ended with Taharah and Taquanda, the two youngest, that are still living with Fred Harris. You've already heard by the charging documents and by the State's opening argument that they are alleged to have also been victims of Fred However, at the time which CPS contacted them, on Harris. January 10th, 2012, this approximately one month after the sexual assault allegation by Victoria that went to Henderson Police Department, and it's approximately a month before the certainty of her pregnancy, and Taharah and Taquanda, the evidence will show, reported to CPS that not only was nothing inappropriate happening to them, but that they did not believe the allegations that were made by their sister Victoria. We're going to ask why.

Enter the summer of 2011. At this point Taharah and Taquanda have been living with Lealer Cooks and Fred Harris for some time. And the children living with Tina and Victoria, the evidence will show, are not faring well in school or in how they interact. Lealer Cooks and to a lesser

degree Fred Harris cease to allow as much contact between
Taharah and Taquanda and their siblings living with Tina Duke.
As you might imagine, that did not sit well with Tina Duke or
Victoria. However, in the summer Taharah and Taquanda were
permitted to go and reside with them.

And then we come to the second sexual assault allegation, the one that brings you here today. On September 27th, at the end of that summer where Taharah and Taquanda were living with their mother and sister, there's an allegation of sexual assault of Fred Harris against the older of the two youngest, Taharah, not against Taquanda. In speaking with Taharah -- this is going to be by CPS -- Taharah claims to have disclosed her abuse to an OB-GYN. Again, another mandated report. And that she did not receive any help. Her statement to CPS was that the doctor's advice was that, well, maybe then she should just move.

Taquanda, the sister, not the victim Taharah,
Taquanda, having heard about the abuse from her sister, also
claims to have informed a H. P. Fitzgerald, it's an elementary
school, I believe she's in fifth grade, counselor by the name
of House, that her sister was being sexually assaulted. This
is the third mandatory reporter being involved in the case.
We've also contacted Counselor House. I expect you will find
that testimony as to whether that was ever said to her
enlightening.

The doctor referenced by the State in its opening, I believe it's doctor Mehta, and she will be flying in from Louisiana.

The last part of the investigation again involved talking to Fred Harris. This was by police detectives. I expect that the State will want to go through that statement with you, and there are things in that statement that I wish I didn't have the contend with. Namely, Fred Harris ever thinking that it was a good idea to have sex with Victoria. What he is candid about, the State is not in error in saying that he initially denied it. He will say in the statement, and perfectly consistent, that he wasn't big on the idea of people knowing that he had done things with both a mother and a daughter. In fact, had it not been for that poor judgment, he probably wouldn't be sitting in the position he's in now. But he is, if nothing else, once he learns that, okay, this has come to roost, candid. You will see that he does not try to hide the ball. When the police ask him questions about, so, you know, what were you doing over here and what were you doing over there, he admits to many things that other people would otherwise leave out, such as, hey, I was over there smoking marijuana. Not that the police knew that, but he included it. When he came out he came clean.

Now, the evidence will show that the reason we are here, other than short-sighted misstep, are, number one, that

the State and its actors -- and when I say the State and its actors I don't mean these lovely ladies at the table, I mean the Henderson Police, CPS, other people involved in putting this case together -- the evidence will show that they're particularly good at rescue, that it's difficult sometimes to make an allegation to be vulnerable, and they're well equipped to getting that information, making an individual feel safe, and prosecuting. However, the evidence will show that what they're not good at is detecting deceit or manipulation.

Next the evidence will show that, having received these allegations, the State did not attempt to corroborate that information whenever possible, such as by speaking to the doctors that the girls claim to have complained to or speaking to the teachers that the girls claim to have complained to or checking the income of Tina Duke, who claimed that she was forced to prostitute herself in order to sustain her children or consulting the school records involving the children.

Now, the evidence will show that the reason why checking these things are particularly important is because you find patterns, and the pattern that the State didn't bother to look at was how the children were faring at the time in which these various allegations were made. The evidence will show that at all points in which the children were living with Fred Harris they had the best academic performance of their lives and that when they left his care those that

continued to go to school did very poorly and that -- that's those who continued to go to school. Those who did not dropped out entirely. The evidence will show that Victoria failed to graduate high school, that Mahlica failed to graduate high school, but that Taharah and Taquanda during the time they were with Fred Harris did exceptionally well. The evidence will show that the most poignant part of that evidence will be that everyone did well when they lived with Fred Harris, but that when Tina Duke moved out with Victoria everyone at the Harris continued to do exceedingly well, but that Victoria Duke failed to graduate. The evidence will then show that when Mahlica and Shabazz moved out to live with Tina and Victoria they failed and that Taquanda and Taharah continued to do exceedingly well.

Some of the State's witnesses will be able to testify to you why that's odd. They will be able to tell you that one of the ways that abuse in a home can be corroborated is that, despite the best attempts to hide it, is that children suffer in school, that they become disconnected, that they don't do their homework, that they don't perform well, they become introverted. And the exact opposite is happening here.

Once this case begins, because there is a sexual assault allegation that leads to the beginning of this case, Taharah and Taquanda are removed from the home. That was in

2013. The evidence will show that between October of 2013, last year, and January of this year Taharah already has 14 absences, Taquanda already has 18 -- I'm sorry, 28, and that their grades are abysmal. You will be able to compare that to letters written by Taquanda and Taharah themselves stating to CPS why they did not want to move with their mother. They will explain in that letter why their education was valuable to them and why they thought they were better off living with the defendant and Lealer Cooks after the timeline established by the State of these allegations.

This is not the first time these parties have appeared in court. You will hear during various examinations that witnesses have appeared before probable cause hearings, evidentiary hearings, et cetera. Victoria is no exception. At the inception of this case last year Victoria appeared and testified under oath at preliminary hearing. She included a lot of allegations, many of which and the most important of which we weren't present to see. However, she provided many that could be checked or verified or corroborated. The evidence will show that one of her biggest missteps in bringing these horrible allegations against Fred Harris is that she also included his daughter.

Now, Victoria and his daughter, whose name is Shaday [phonetic], haven't seen each other in quite some time. The evidence may show that Victoria doesn't recognize Shaday or

didn't at the time. It will also show that she didn't know that Shaday was in the room watching the proceedings. Victoria made an allegation that she was not only Fred Harris's victim, that her sister Taharah was Fred Harris's 5 victim --Objection. Can we approach? 6 MS. LUZAICH: 7 THE COURT: Yes, you may. (Bench conference) 8 It's opening statement. 9 THE COURT: I know. And I'm sorry. I think he's 10 MS. LUZAICH: going to misstate what happened. Victoria did not say that 11 Shaday was a victim. Victoria then testified under oath that she was informed that Shaday was also sexually assaulted, and then all hell broke loose. So they will come and testify and include all of those other details. But suffice it to say that there was not order in the court.

Ladies and gentlemen, the defense expects that the evidence will show that the Duke children certainly have not had enviable lives and that much of their misfortune is the fault of their mother, not necessarily deliberately. We do not have to prove or disprove that she is doing her best or not doing her best. But it will become abundantly clear that these children have never had a fair shot and that one child, who was almost an adult, Victoria, it was already too late to save her, that she was a lost child and that she had good reason to be angry, if not at her mother, then the whole world. She had been taken away from her family, and she felt as though this man was to blame. The evidence will show directly, not even by inference, that one of the reasons she blames this man is because she can't blame her own mother.

It's her mother, and try as she might, she has to love her.

The evidence will show that from its inception the allegations made against Fred Harris by Victoria Duke were and were always back then false.

The evidence will show that the reason why nothing ever happened that changed these circumstances was because no one agreed with her, but that when the opportunity arose to enhance her own story with another one of her siblings she took it. And she had to wait a long time for that opportunity. The evidence will show that when she had an opportunity to spend significant periods of time with her younger siblings that their allegations would arise and that their testimony would change. The reason you're here is to determine whether or not that changed because they were manipulated or did it change because they felt comfortable disclosing to their sister, as opposed to doctors, teachers, police, CPS workers, and counselors, all of whom had attempted to make contact and rapport with these children in order to make them feel safe to bring such an allegation if it was warranted.

The evidence will probably show that the worst part of State's case in contrast to ours is the inconsistency of Tina Duke. She is at times a wholehearted supporter of Fred Harris, she is at other times a woman scorned, jealous that she cannot have an exclusive relationship with him because he

always seems to put Lealer Cooks first, he's having two relationships in the open, and there's jealousy.

Ladies and gentlemen, Tina Duke, not unlike her children, has had a rough life, and perhaps the most telling way to characterize her testimony and her motivations can be found in her most recent book. She fancies herself a writer, and she writes, at least in her characterization, about true events that have happened in her life. The most recent book that she has submitted --

I think that the statute requires that they update their witness list as soon as, you know, addresses change and things such as that; and that wasn't provided.

Additionally, I did file a discovery motion. I think it was listed in the discovery motion, all of the things -- and that was one of them, update witness lists. And I did never receive that.

MS. LUZAICH: We've talked on pretty much a daily basis, and she hasn't said anything before that she didn't have any information. I don't know if -- I just -- I'm not seeing it right now. I don't know what it says on the witness list. But all she had to was ask me, and I would have given it to her. And I will. I'll give her the phone number that we have. I don't have it. My investigator does.

But the fact that they want to only bring in the name of the book is completely inappropriate, because it has nothing to do with this. And they're trying to make it sound like she is writing this sweet revenge book and it has something to do with this and they're going to try and correlate the two. And that's not fair. Because in order to demonstrate that it has nothing to do with this we would have to bring up the fact that it dealt with her

rape when she was 14. And that's rape shield. So they're trying to get a little bit of information that has no bearing whatsoever on this case and use it in a way that is misleading. I knew there was a word. I just couldn't get it. Sorry.

MS. ALLEN: And I don't know that it's misleading.

Again, we're not trying to get into this rape or whatever's going on there. I'm sure there's plenty of events in the book regardless -- or save and apart from this alleged rape, but it sort of gives you an idea of sort of this woman's life and the kind of --

Pardon?

Oh. I apologize. I thought Mr. MacArthur said something to me.

-- but sort of the kind of motives that she has in her -- the way she uses things and what she does and the motives that she has in her life. And, again, you know, the defense in this case has always been that this was sort of payback originally cooked up by Victoria, but, nonetheless, payback for all this and her involvement in it. Not looking to get into anything, like I said, related to rape shield, simply that she wrote a book, that she has motive, that that's a motive -- that correlates to her motive to lie here, like it's a revenge tactic, like this isn't -- she's obviously writing about it in this book. And so I'd submit it with
