### MEMORANDUM OF POINTS AND AUTHORITIES

### I. Relevant Facts, Law and Argument

On June 5, 2020, the appellate court filed an Order of Affirmance in Case No. 78193-COA. Pursuant to the relevant rules of Appellate Procedure Appellant Alfred Centofanti had 18 days to file a Petition for Rehearing or until June 23, 2020.

Centofanti received a copy of the June 5, 2020 decision on June 12, 2020.

On June 12, 2020, Centofanti submitted a kite in which he put in a "request for physical appointment. Attached as Exhibit "A". This kite was returned and Centofanti was verbally informed that he needed to make a request to Associate Warden Hubbard Picket.

On June 15, 2020, Centofanti sent a written request to the Associate Warden. This kite was never provided a response. Exhibit "B."

On June 15, 2020, Centofanti was provided limited materials that were utilized in preparing and mailing for filing (on June 15, 2020) a Petition for Rehearing. Exhibit "C." Centofanti also mailed for filing a request for Leave to Amend the Petition once he had access to the law library and the materials needed to supplement the response.

On June 25, 2020 submitted a second request for materials and for an appointment. Exhibit

It is now July 2, 2020, and Centofanti is being denied the ability to have a physical appointment at the law library. This materially prejudices his ability to prepare a proper Petition for Rehearing and Supplement. HDSP operates a Prison Industries which employs over 100 inmates full time (as well as a culinary that employs over 30 inmates per shift) yet cannot figure out how to allow one inmate with a demonstrated need to attend the law library to comply with legal deadlines. Similarly, there is no procedure for inmates, and for Centofanti, to make outgoing legal calls during business hours, and legal mail is often delayed.

All of these restrictions on Centofanti have impacted his 6<sup>th</sup> Amendment Rights to represent himself and also his Equal Protection Rights as other similarly situated inmates (not legal library workers) are allowed to attend.

Centofanti is the appellant in the above-referenced matter proceeding in pro per. Centofanti is an inmate currently housed at HDSP and resides in Unit 7A. Centofanti has done everything in his means to get approval for attendance and comply with applicable deadlines. There is no other option for Centofanti then to ask this Court to consider and Order the Following:

- Hold those at HDSP who are responsible to ensure that inmates are allowed access to the law library in Contempt and/ or Sanction them in an amount commensurate with their conduct that has denied and continues to deny Centofanti access to the law library or the alternative legal calls to those outside of prison to seek assistance by pphone;
- 2. Order that Centofanti be allowed to submit the Concurrently filed Supplement and to Stay the Proceedings unit! such time that he is allowed access and can properly respond to the issues raised in the June 5, 2020 Order of Affirmance both in fact and in law;
- 3. Allow this Motion to be filed with any deficiencies due to Centofanti not having access to the materials needed; and
- 4. Whatever other relief the Court deems appropriate under the facts and circumstances.

### Procedure:

Inmates will complete this form and submit it to the law library supervisor. Incomplete or incorrectly filled out forms WILL NOT be processed. Send form through inter-departmental mail or via the Unit Law Library Mail. Do not give to count officers.

The law library supervisor shall review the request, authorizing those materials which may be issued.

The inmate librarian will fill the request, based on the Supervisor's authorization and will then give the items to the librarian assigned to the inmate unit for delivery to the inmate.

The inmate librarians will make the appropriate entries pertaining to the checkout of books, due dates and the issuing of supplies.

## Check In/Check Out

Each inmate may have up to ten (10) law books (case laws and reference) checked out and in their possession at one time. Each file folder containing WestLaw "pink" pages will be considered one book.

CD ROM Legal materials may be checked out for one consecutive 10 day period and renewed every 10 days.

Hardbound Legal materials may be checked out for one consecutive 10 day period. If the hardbound does not have a wait list, then another 10 day period will be granted. This rule will make it possible for all inmates to use these materials.

All inmates may "Check-in" and "Check-out" legal books and request supplies/copy work Monday through
