9 Comes Now, Alfred P. Centofanti, III, in Pro Per, and hereby files his 2nd
10 Supplement to the July 2, 2020 (mailing date) Motion for an OSC, the Motion
11 for stay and other relief, the August 10, 2020 (mail date) supplement as
12 follows:

13 On August 10, 2020 Centofanti requested he be allowed to attend
14 the law library. In response to "what can be done to resolve this
15 issue?" Centofanti was told:

16 "Find a cure for covid 19."

17 A copy of this exchange is attached as Exhibit "A."

18 On August 18, 2020 the brain trust at HDSP decided to start a
19 schedule that provided 28 inmates would be allowed out of their
20 cells at one hour intervals in which to 'share' five (5) telephones,
21 eight (8) showers, one (1) kiosk, one (1) microwave, etc. But still no
22 law library (workers only) and 100+ at PI, 30+ in kitchen, etc.

23 This doomed to fail scenario lasted less than 1 week. Fights over the
24 phone in multiple units, including an alleged stabbing in unit 7c/d

25 in unit 7 A/B) has at least unit 7 on lock down
26 SEP 10 2020 (again), yet now PI workers go to work and still no
27 law library access for unit 7.

Furthermore, Centofanti is being held hostage by both mismanagement
and a situation not of his making. HDSP is supposed to be a medium
custody yard not a 'supermax'. Despite a warden and 4 associate
wardens, and multiple LT's, SGT's and admin. assistants, they can't figure
out how to run either the prison or law library without the benefit of a
Court order, so let's give them one. Please. Along with a stay:

This Court is therefore, again, requested to order Centofanti be
allowed to attend the HDSP Law Library to conduct necessary
research, drafting, copying and processing for litigation before
this Court and not require Centofanti to find a cure for Covid-19.

A reasonable accommodation would be to allow Centofanti to attend
with GP level one workers with whom he is already housed with.
