11 Comes Now, Appellant Alfred P. Centofanti, III ("Centofanti"), in Pro Per and hereby files
12 this Motion to Stay Remittitur and Other Relief (Leave to file En Banc Reconsideration).

13 This matter is presently pending before this Honorable Court as to Centofanti's
14 Request for Reconsideration of the decisions of the Court of Appeals.

15 Due to the delays inherent in Centofanti's incarceration, no internet access, and
16 reliance on the unreliable USPS and NDCC/HDSP legal mail procedures, Centofanti
17 requests the following prospective relief in order to preserve his Right to Due Process,
18 Fundamental Fairness in future proceedings, if relief is not granted:

19 (1) Stay the issuance of the remittitur to allow Centofanti to pursue further relief and
20 (2) Give Centofanti Leave to file for En Banc or other Reconsideration outside the deadlines

21 Both requests for relief are made and based on the MRAP, the Rules of this Court, as well as
22 this Court's inherent powers. It should be noted Centofanti's Feb 9th motion not received until
23 Feb 17th, and this Court's Feb 26th Order (21-05790) not received until March 5th. There is also the

24 issue of ~~lack of~~ lack of law library access, lockdowns, and resources, which point to
25 the need for MRAP time to proceed in a meaningful manner.
