



The subject matter of this case is the mental competency of Loretta 12. Powell pursuant to a 4 month psychological evaluation to determine competency in handling day to day personal affairs. Plaintiff claims that physician certification implemented by Loretta Powell and Harmony Healthcare 1701 w. Charleston, was either in good faith or fraud. Defendant had received a large PI settlement in or around March 2015. Defendant should have approx. 250,000 left over as surplus. Defendant is living in the ghetto neighborhood of 8<sup>th</sup> and Ogden Avenue now for almost 4 years approx. Plaintiff came to live with defendant pursuant to a verbal agreement for room and board in exchange for Plaintiff saving money, getting healthy and caregiving when needed. Plaintiff discovered upon the date of his move out that Defendant may not be thinking clearly as she was mentioning in drunken stupor that she had money put away for retirement and around \$20,000 for her son Anthony. Plaintiff asked the defendant to rescind the Department of Education's dismissal of defendants Stafford loan of approx... \$4300 and Defendant refused. Plaintiff then discovered that David Powell and Monica Thiede, David Powell's partner in crime, may have possibly conned Loretta into allowing them control of her monies and they would help her save it. Plaintiff surmised suspicion based on several conversations with defendants sister and David Powell. Plaintiff blew the whistle that she had gotten the aforementioned physicians certification for mental disability and incapacity to handle day to day to get out of a Federal Stafford Loan thru the Department Of Education. Plaintiff confronted defendants first and foremost David Powell of which all defendants lied about monies hidden from the State of Nevada, The Department of Treasury, and the Department of Education. Plaintiff filed for Guardianship since the Defendant, his mother, cannot be thinking well since what Harmony Healthcare had done would be

felony fraud. Defendants filed objections which were a compilation of slanderous defamatory lies designed to sway the court. Plaintiff Objected to their perjurious statements of which Judge Sturman ignored his objection. Court inquired if Mr. Powell had a criminal record.

Following extensive discussions, Mr. Powell admitted he had a record in California; however it was sealed and was from over 10 years ago.

Ms. Valenica stated the physician's certificate submitted indicated she was able to execute a Power of Attorney and that she'd requested the least restrictive means of assistance.

Upon inquiry by the Court regarding what the doctor was looking for, Ms. Valencia stated he looked a memory and if the person can understand what they are signing. Ms. Valencia further argued she'd submitted a physician's certificate from a neurologist who stated she was able to understand and was competent to make decisions regarding her future.

Court stated that was contractual capacity which was a higher level of competency.

Ms. Anderson argued the PP objected and further requested his petition be dismissed, that the pleadings were inadequate, that the physician's certificate and other documents indicated the PP was capable of making decisions, and that Mr. Powell's documents were more toward being unhappy with the decisions the PP was making.

Court discussed at length the levels of capacity and the strict requirements that must be met to order a guardianship.

Ms. Anderson stated the neurologist indicted she should take her medication; however he did not say she was incompetent and further advised the PP was requesting an order of protection as she was fearful for her safety.

Following extensive arguments by Mr. Powell and counsel, COURT ORDERED, Motion to Dismiss Petition for Guardianship GRANTED.
