**MOTION FOR LEAVE TO FILE A PETITION FOR EN BANC
RECONSIDERATION AND OTHE RELIEF**

COMES NOW, Appellant Alfred P. Centofanti, III, (hereinafter
“Centofanti”), in Pro Per, and hereby files this Motion, pursuant to NRAP 26, to
request he be allowed leave to file a Petition for Re Hearing En Bank pursuant to
Rule 40-outside the 10 day time limit.

The reason for this Motion is that due to the fact of Centofanti’s
incarceration, there is no method or way for him to comply with the 10 day
timeline. Currently due to the Covid-19 crisis Centofanti’s access to those
resources needed to prepare and file a response are either being denied to him (the
law library) or severely curtailed (access to the incoming and outgoing mail) such
that he is respectfully requesting he be given leave of at least 30 days from the date
of any denial of the pending Petition for Rehearing in which to file a Petition for
En Banc Reconsideration.



By way of an offer of proof, the June 5, 2012 Order of Affirmance was not in fact delivered to Centofanti until July 12, 2012, a full 7 days later (and on a Friday). Centofanti has been denied since that date access to the law library and the inmate store has been closed since June 22, 2020 so as to prevent Centofanti from being able to purchase envelopes, paper and postage and further limited from access to the kiosk to order the supplies. Additionally, Centofanti's access to the telephones is similarly limited which limits his ability to seek outside pro-bono assistance.

Centofanti is attaching a copy of the July 1, 2020 "response" he received July 2, 2020 to his June 15, 2020 request for access to the law library. (see, attached Exhibit "A"). This Court is asked to take judicial notice of the fact that from June 15, 2020 to the present:

- The HDSP law library has been open for physical access to free staff, inmate workers, HDSP custody staff, as well as "appointments" in the form of select inmates as chosen by HDSP staff, believed to be free staff (law library supervisors) in conjunction with the Associate Warden of Programs (believed to be Ms. Monique Hubbard-Pickett).
- The attendance and other records of HDSP not available to Centofanti would prove all of the above.

- Centofanti was told by custody staff Spry on Friday, July 10, 2020, that on that day 3 non inmate worker inmates were allowed access to the law library.

Why an inmate with a demonstrated provable need for physical access who make a timely request within a Court Ordered deadline (here June 23, 2020) is not only denied access but is lied to about it is something that perhaps should be addressed in not only in deciding this Motion, but be considered in the previously filed Motion for an Order to Show Cause.

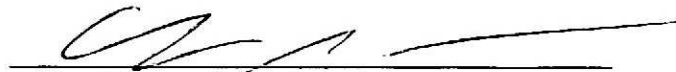
Centofanti believes, and in good faith, is pursuing relief in reconsideration in good faith on the basis that the facts and circumstances of judicial interference and counsel conflict are important issues of public policy which need to be addressed for Centofanti's and future cases.

THEREFORE, Centofanti respectfully requests the following relief:

1. That Centofanti be given 30 days from the date of the denial of the Petition for Rehearing in which to file a Petition for En Banc Reconsideration;
2. That this Motion be heard in conjunction with the previously filed Order to Show Cause which is pending before this Court.

3. Any further relief deemed appropriate under the facts and circumstances of this case.
