9 IN Order to comply with this Court's January 3rd deadline to file an Amended
10 Petition for Reconsideration Centofanti sought the assistance of an out of state law firm
11 in pro bono to assist in the preparation and filing of the Amended Petition.

12 Centofanti mistakenly believed filing could be done electronically on his behalf.
13 Centofanti did not learn until after his am time on 12/30 that electronic filing was
14 not possible. He left a message through his family that the deadline could not be missed.

15 HOSP went on a security lockdown from January 1st until Jan 5th (no phone access)
16 On January 5th Centofanti was informed the brief was received in time by the clerk.
17 On January 6th Centofanti received a copy of the brief of December 29th.

20 timely filed Amended Petition out of an abundance of caution to ensure the
21 filing complies with the NRAP and of this Court.

28 electronically as previously ordered and allowed by the Court

1 without the ability to sherardize or research (unable to respond to good cause finding of the Court
2 of Appeals, comply with rules, deadlines). Direct access to the library is necessary because the
3 prison law library is not staffed with anyone trained or qualified to give legal advice.


4 What this Court is asked to do by way of review is to provide guidance as to relief
5 available to proper incarcerated inmates, such as Centofanti, upon a colorful allegation or showing
6 of denial of access to the Courts (and not a 42 USC 1983 Civil rights action for money damages)
7 such as stay, sanctions, appointment of counsel, or other relief (Court Ordering access and setting
8 revised Briefing schedule and deadlines) deemed appropriate in the interest of Justice to ensure the
9 fairness of proceeding for all.

10 As to Centofanti, he seeks a review of the facts, documents, and evidence submitted July 2,
11 August 10, and August 26th as to the denial of access to the Courts (HDSP law library), hindering
12 his ability to address issues in respond to deadlines. The relief Centofanti seeks is the ability to
13 research and draft a response to the June 5, 2020 Order of the Court of Appeals either with the
14 assistance of counsel, and/or after Court Ordered access to the law library pursuant to a Briefing
15 schedule if relief is not otherwise granted, Reasons 1-4, supra. Without this Court's intervention or
16 direction, the NDOC can violate inmates' access to the Court's rights without accountability since
17 the appeals Court, while providing a copy of the July 2, 2020 Order to the Attorney General, did
18 not Order the Attorney General or their client, the NDOC, to respond, therefore evading review.

19 **Conclusion**

20 Centofanti requests review by this Court of the June 5, 2020 Order of affirmance and
21 August 24, 2020 Order denying rehearing pursuant to NRAP 40B as to each of the five (5)
22 questions and reasons set forth in this Petition.


