The date on that line should be corrected to read:

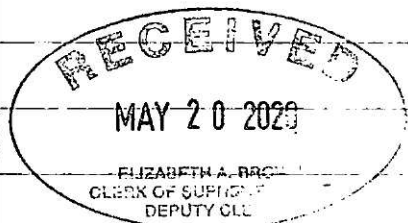
"The fact that the district court's order also sets a hearing date for

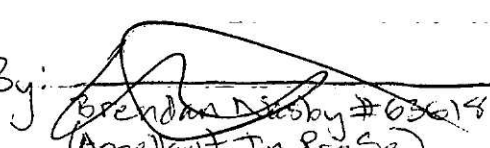
