ADMINISTRATIVE ORDER # 20-14

WHEREAS, JCRLV 6.5 allows the Chief Judge to make "such orders as deemed advisable" relating to local court rules and procedure; and

WHEREAS, the COVID-19 virus presents concerns regarding public health, and the Court wishes to minimize risks relating to in-person contact; and

WHEREAS, the Court recently issued Administrative Order #20-13 and mandated face coverings for all Court employees; and

WHEREAS, the Court has determined that the scope of that Order needs to be supplemented; therefore,

IT IS HEREBY ORDERED that anyone who enters a public area of the Las Vegas Justice Court must wear a face covering; and

IT IS FURTHER ORDERED that this Order expressly applies to, but is not limited to, private attorneys, contract counsel, employees or attorneys of the Clark County District Attorney's Office, employees or attorneys of the Clark County Public Defender's Office, court reporters, and all members of the public; and

IT IS FURTHER ORDERED that children under the age of two and individuals who are unable to remove the face covering without assistance do not have to comply with the above-referenced face-covering directive; and

1 **IT IS FURTHER ORDERED** that individuals who are unable to wear a face covering for a
2 Court proceeding should make arrangements to appear by alternative means; and

3 **IT IS FURTHER ORDERED** that, as used in this Order, "public area of the Las Vegas
4 Justice Court" includes the following locations:

5 (1) The Traffic Division located on the 1st Floor of the Regional Justice Center (once that
6 area is re-opened to the public);

7 (2) The Customer Lobby for PreTrial Services located on the 1st Floor of the Regional
8 Justice Center;

9 (3) The Customer-Service Counter located on the 2nd Floor of the Regional Justice Center;

10 (4) The Court-Education Division located on the 4th floor of the Regional Justice Center;

11 (5) The Neighborhood Justice Center located at 330 South Third Street, Suite 600
12 Las Vegas, NV 89101 (once that area is re-opened to the public);

13 (6) The Community Impact Center located at 3740 Royal Crest Street, Las Vegas, NV
14 89119 (once that area is re-opened to the public); and

15 (7) All courtrooms utilized by the Las Vegas Justice Court, including, but not limited to,

16 * Courtroom used for Initial-Appearence Court in the lower level of the Regional
17 Justice Center;

18 * Courtrooms used for Traffic Court in the lower level and 1st floor of the Regional
19 Justice Center;


20 * Courtrooms throughout the Regional Justice Center that are used for Small- Claims
21 proceedings on an as-needed basis;

22 * Courtrooms used for Eviction Proceedings; and

23 * Courtrooms used by the justices of the peace for Criminal, Civil, Protection-
24 Order, and all other types of proceedings.

25 **IT IS FURTHER ORDERED** that this Order shall be reviewed no later than every 30 days
26 and shall remain in effect until modified or rescinded by a subsequent order.
