A It's a squad of seven to eight detectives on Metro that handles any alleged sex crimes if a victim is under 18 if the alleged perpetrator has some kind of position of authority over them, lives in the same home, first degree family relationship, or any victim who is under the age of -- alleged victim under the age of 9 years regardless of the relationship to the alleged offender.

- Q Okay. Are there times that you do your investigation alone and times that you kind of hook up with another agency?
 - A Yes.

- Q How does that come about?
- A Our squad is actually housed with a team of Child Protective Services sex abuse investigators at a place called the Southern Nevada Children's Assessment Center. We're housed in the same building with CPS, some mental health professionals, some victim advocates who assist with counseling. If a case comes in that requires both CPS and law enforcement response, we try as much as possible to work a joint investigation.
- Q What would require CPS and Metro to work jointly as opposed to where you would work alone?
- A I'm not familiar with all of CPS's criteria for what does and does not constitute a case for them, but in general anytime a parent, quardian who is in the home or has some kind

of custody over the child is the alleged perpetrator, CPS will get involved for the civil aspect of the case for guaranteeing the safety of the child, the welfare of the child.

Q Okay. And --

- A And to assist the non-offending parent with the resources to -- to help them understand what's happening.
 - Q Do most of your investigations also involve CPS?
- A It's difficult to say most because the nature of what we deal with tends to -- a lot of our cases tend to come up years after the fact, at which point there is no need for CPS involvement, the child has either aged out of CPS's jurisdiction, they're no longer in the same home, the offender is no longer near them. But I would -- I would say maybe half of our cases do involve CPS whether locally or from another state, and most of our reports now come in through the CPS hotline.
- Q Okay. And the instances wherein you do work with CPS, do you try to partner up with somebody from CPS very early on in your investigation?
- A Yes, that's the whole point. That's the best practice is to have both parties to the investigation working together as early as possible.
 - Q Why is that?
- A There have been several trainings that we received that show that a joint investigation tends to be better for

the welfare of the child, for the family, for everyone involved, rather than having to have the child and witnesses come in for repeated interviews, having to relive this over and over again, especially for a young child who might be traumatized. It tends to be more beneficial to them to only have to tell their story once.

Q Okay. And can you describe for us what training and education you have that helps you do this?

Specifically for this job I've attended several Α interview and interrogation schools, just general interview and interrogation schools. I've attended several forensic interview training, including a week-long course put on by First Witness, another week-long course put on by personnel from the Huntsville, Alabama, CAC. I have been -- I was lucky enough to attend the Dallas Internet Crimes Against Children's abuse -- child abuse conference in Dallas in 2009, I believe I attended. Metro used to host something called the Western States Sex Abuse investigator seminar every summer. attended, I think, four of those before the budget made it impossible for that to continue. Several -- several classes put on by the public agency training counsel specifically to deal with sex crimes investigations, understanding sexual offenders, several classes like that.

Q So would you agree that investigating crimes against -- involving sex offenders is different than investigating,

for example, robberies or property crimes?

A I would say so.

- Q And especially because children are involved.
- A Yes. And the reason we have a squad dedicated to our type of crimes is even amongst sex crimes investigators there are a lot more unique considerations involved in an interfamilial case than a stranger case.
- Q Okay. I'm direct your attention back to September of 2012. Were you working as a detective in the sexual abuse detail at that time?
 - A I was.
- Q Did you become involved with a case that -- sorry, did you become involved in a case that involved Taharah and Taquanda Duke?
 - A I did.
 - Q How did you become involved?
- A It was assigned to me by my sergeant. The case came in through the CPS hotline, and it was what we refer to as a same day response, which means if a child is in potential danger during our shift where if we don't go speak with them, find out what's going on before our shift is over they might have to return to a dangerous environment and someone may have access to them that is an alleged offender. I was told by my supervisor, Sergeant Schultz, that this case had come in. He gave me the report. He told me that CPS specialist Sholeh

Nourbakhsh had been assigned and was already going to the 1 2 school to speak with the children, to get them to bring them 3 back for interviews. 4 You say he gave you a report. What information did 5 you have at the time? They information I had, I don't remember all of the 6 Α 7 details, but it was a case that was called in by another 8 juvenile in the home saying she had concerns that her sister 9 was being --10 MS. ALLEN: Objection, Your Honor. Hearsay. 11 THE COURT: Sustained. BY MS. LUZAICH: 12 13 Okay. A juvenile called into the hotline and that's 14 how you got involved? 15 Α Yes. 16 Did you learn the name of the juvenile that called 17 into the hotline? 18 Α I learned the name, but I -- throughout this case I 19 get the names of the two siblings mixed up. BY MS. LUZAICH:

Q So you said that -- that there was prior history. Did the prior history have notes that you could at least access?

- A It did.
- Q Did you access the notes?
- A I did.
- Q And what is the reason for accessing the notes?

A First and foremost to see if the matter that we are currently investigating has already been investigated in the past, if it's something that someone else has already dealt with. We sometimes will get cases called in years later by a therapist or a school counselor if a child talks to them about the matter. And sometimes we will learn that this was already dealt with two, three, four, five years ago and there's no need to go through the whole thing again. And then besides that it's just a general investigative step to find out who is involved, what other allegations may have been made in the past, if we have any reason to doubt the -- the validity of what's being alleged now, if there's any red flags in what's being alleged in the report.

- Q Okay. So you looked and found prior stuff. Then what did you do?
- A I just researched records. I researched databases, Metro databases for old reports for running people's

histories, and then I just waited for Sholeh to return with the children so that we could observe one of the forensic interviewers interview Taharah and Taquanda separately.

- Q Did you cause there to be forensic interviews set up?
- A Sholeh and I did. I don't remember who exactly scheduled the appointment.
- Q And tell me, what is a forensic interviewer, first of all?
- They're not law enforcement. They're not CPS. Their job is they interview children. They conduct what are called forensic interviews by appointment at the center. And they do it primarily on alleged sex abuse cases, but they will assist if -- in any case where a child needs to be interviewed. They will -- they will do those interviews as requested.
- Q And you say that the forensic interviewers there are not employed by either Metro or CPS; correct?
 - A Correct.

- Q So they're objective interviewers?
 - A They are County employees, but I don't know exactly who they are employed by. I know they're not considered CPS or law enforcement.
 - Q Okay. And who was the individual that was going to interview Taharah and Taquanda?

1 Α Michele Fisher. 2 You said that you prepared to observe the 3 interviews. Why do you observe and not participate in the interviews? 4 5 Α It allows a measure of objectivity. Michele doesn't 6 have a stake in the investigation one way or the other for any 7 agency. I have also personally found that I am better able to 8 pay attention to what is said in an interview if I can watch from -- we have a closed-circuit television in the observation 10 room. It's easier for me to watch and pay attention to what's 11 being said that way than if I'm actually in the interview and 12 I'm the one speaking with the child. 13 0 Okay. And when you watched the interviews, were you 14 alone or was anybody with you? 15 Α Sholeh was with me. And just you and Sholeh? 16 17 Α Yes. 18 Parents are not allowed to watch the interviews; is 0 19 that correct? 20 Α Correct. 21 Or guardians or anything of that nature? 0 22 Α Correct. 23 0 It's just a law enforcement kind of tool? 24 Α Law enforcement or CPS. 25 Okay. Α Tina Duke. 9 10 Now, before I even get to Tina, did you arrange for 11 something else to happen with the girls that day? 12 Again, I don't remember if it was myself or Sholeh that did it. When we work a joint investigation it's just 13 14 kind of whoever picks up the slack first on certain aspects. 15 But we did arrange for the girls to have medical exams at the 16 CAC clinic. 17 0 Okay. And would that have been Dr. Mehta who did 18 the exams? At that time it would have been, yes. 19 20 Did you also in your investigation earlier learn 21 about some -- a Henderson Police Department investigation? 22 Yes, when I was researching the initial records I 23 learned there had been a previous investigation by Henderson

- 1 Α I did. 2 0 At what point did you do that? 3 I don't remember the exact timing of that. I now 4 sometime during the initial day of the investigation I left a 5 message for Detective Aguiar in Henderson. 6 I guess that would be my question. So it was that 7 same day that you contacted Detective Aguiar? 8 Α I can't say for sure. I think it was. But it was 9 either that day or first thing the next shift that I worked.  - Q And did you get anything from him?
- 24 A I did.

Q What did you get from him?

he conducted regarding the same -- the same people, family.

A He provided me with a Henderson Police Department report. It included several case notes, and he also provided several transcripts. I don't recall if he sent me CDs or emailed me sound files, but I know I got something from him on a disc. I think it was CDs of audio interviews.

Q Okay. And you said he provided you some transcripts. Did you have to get some of the things that he sent you transcribed?

A I did.

Q Now, when you guys do interviews, ultimately they're on some sort of disc or something; correct?

A Yes.

Q How do you, the Las Vegas Metropolitan Police Department, get your interviews transcribed?

A The process has actually changed a little bit over the last year and a half or so, so I don't remember if this case was done the old way or the new way. The old way was we would simply burn our interviews onto a CD, we would provide them to the clerical staff at our headquarters. Some of the interviews would be done by the clerical staff there, it would be transcribed. Some will get shipped out to a company called Net Transcripts just depending on how backed up somebody is, what the case load is like. At some point we've adjusted to where we submit them electronically via email to our same clerical staff and from there it goes the same way. Sometimes

they will do the transcriptions, a lot of the time it will get sent out to Net Transcripts.

- Okay. So how long did it take before you got the items from the Henderson Police Department?
- I don't remember exactly. It was -- it was several days, if not a few weeks.
 - 0 Awhile, not immediate?
- Α Right. And Detective Aguiar did warn me it would take awhile to compile everything because he had since left and been assigned to a different unit.
- Okay. So you got the girls examined, you spoke to the Henderson Police Department. You said that you had tried 13 to contact the mother. Did you ultimately have contact with the mother of the kids?
- 15 Several days later we did.
- 16 Q Was that after a hearing in family court?
- Yes. 17 Α

Q Did she describe a series of incidents, events, however you want to phrase it, to you?

A She did.

Q Did she have some difficulty in relaying some things?

A Yes.

Q At the conclusion of her interview, did you ask her to do something?

A I did.

Q What did you ask her to do?

A Tina had provided a lot of information during her interview and at different times she seemed to be confused and at different times she was confusing me. I wasn't understanding exactly what she was telling me as far as time frames. I asked her if she would be able to put together some sort of time frame, maybe even a timeline of events to describe the incidents that she had -- she had alleged to

myself and Sholeh.

- Q And did she ultimately do that?
- A She did.
- Q All right. How did she do it?

A Initially she just brought back a one-page sheet of paper kind of summarizing everything she had said in the interview in a very succinct manner. I explained to her that wasn't really what I wanted. I wanted something a little more detailed to really help me understand what she had told us. So she brought back something else several days later that was basically a written statement that she wrote down on her own paper.

Q Okay. Not at your -- like not while you stood there over her?

A No, no, no, no. She brought it back. The first one she brought back a day or two later. The second one she brought back two or three days after that.

Q Okay. Now, just to be clear, after you interviewed the kids you said you tried to contact Tina. How easy, difficult, or what was it to ultimately get in touch with her?

A Between myself and Sholeh, we made several phone calls. I never went to her last address because we knew there was a family court hearing coming up. If she wasn't at that family court hearing, we would have immediately gone to her last known address to speak with her then, but she was at the

1 family court hearing. When you say that you and Sholeh both made phone 2 3 calls, did you leave messages, for example, hey, this is Detective Madsen, please call me? Sholeh left messages. I don't recall if I did or 5 Α 6 not. Okay. But did she ever call either of you back? 7 Q She didn't call me back. I don't know if she called 8 Sholeh back. Okay. When she was at the family court hearing, did 10 0 she also bring kids with her for you guys to interview? 11 She did. 12 Α Who did she bring with her? 13 0 I'm not sure if I'll remember all the names. 14 brought Shabazz, Mahlica, and I think that's it initially. 15 Okay. - A He told her that they were prescription and I don't remember if he did take them off or not. I think he offered to anyway, but when she learned they were prescription she said he didn't need to.

- A He seemed like he might have been a little delayed. He was very relaxed, very calm. He -- he didn't seem to be phased by anything that was going on at the time.

 - A I only saw little brief moments of Mahlica's interview.
- Q Okay. You know that there was another child, as well; correct?
 - A Correct. Well, I knew there was another person involved. By this point --

BY MS. LUZAICH:

- Q And in the big scheme of things, unless you, the collective you, the police agency, submits charges to the DA's office charges don't get filed?
 - A That's correct.
- Q Ms. Allen also asked you questions about did you pull school records. Do you generally pull school records for kids?
- A Me personally, only if the school is somehow involved in the investigation, if the initial report came because of something that a teacher or counselor was told, observed, concerns they had because of the child's behavior. But it's -- I simply wouldn't have the time in every case to pull school records and counselors' records for every kid on every case. Only if someone is said to have some relevant information will I do that.

- Q Okay. In your experience teachers, counselors, people that work at school, they're mandated reporters; right?
 - A They are.

- Q And do -- are there often times that you get cases because a teacher, counselor, or somebody at school has reported?
- A Yes. Our caseload increases during the school year because counselors and teachers generally are -- well, not generally, but a lot of times they're who a child will go to first about something like this.
- Q And in those situations you indicated that you would have pulled records?
 - A Yes.
- Q In any of the investigation or interviews that were conducted as far as you know in this case were you, the police, told that one of the kids had reported to a counselor or a teacher?
- A Not to my recollection, no.
- Q Ms. Allen also asked you about did you interview everybody that was ever living in that home. And you said it's not necessarily something that you need to do. Why is that?
- A With what we deal with specifically these tend to be allegations of things that occur behind closed doors with no witnesses that people generally don't talk to other people

- about. Again, it's just like with the school. I'll only talk to people who are alleged to have relevant information.
- Q Okay. And she also kind of asked you did you ever talk to -- did you try to talk to anyone who ever lived in the home. I mean, isn't that kind of broad?
- A Yes. And, unfortunately, our caseload just won't allow that.
 - Q She was asking you about Taharah, Tina, and Mahlica's statements being different. Now, when you spoke to Tina was it kind of difficult getting information from her?

- MS. ALLEN: I would object as to leading.

- Q Okay. And those are yours. Do you also get to work on cases with your other detectives, like somebody else's case? Do you participate in their investigations sometimes?
- 16 A Yes.

- Q And in your experience do kids always report right away when somebody hurts them?
- 19 MS. ALLEN: Judge, objection. Leading.
- 20 THE COURT: You are leading. Sustained.
- 21 BY MS. LUZAICH:
 - Q Well, how often do kids report right away when somebody hurts them?
- A There's no way to tell. We are generally -- a lot of this training we get suggests that the reason we need to

approach these investigations differently, I guess, is because we're asking kids to talk about things that are maybe shameful or embarrassing and that they had been told repeatedly by someone with authority over them we don't talk about. So we know -- we know going in that not every child is going to talk to us about what's happening.

Q Okay. And in your personal experience have there been other situations where that has happened, where a child didn't say something and then later did?

A Yes. It's a common practice for us that even if a child does not disclose we refer the family to victim counseling through our victim advocates at the Center, because it tends to be the case in some cases that a child will later disclose through counseling, and then we can take another look at the case later on.

Q In your experience are there other factors that also enter into what might make a child more comfortable before they're ready to disclose?

A Yes. There are a number of different things that can enter into it.

Q Just for example?

A There's fear, there's shame, there's embarrassment, there's family pressures. A lot of -- a common one we get is a child will be keenly aware that if they say something about the provider in the home their family will lose their home,

they'll lose their ability to have food on the table, they might get taken away and placed into Child Haven. There's hundreds of different considerations unique to each child.

- Q Do sometimes kids just not want to talk about it?
- A Yes.

- Q Has it been your experience sometimes that it also depends on who's asking the questions?
 - A Yes, it can.
- Q Have you been in the situation where sometimes kids are more comfortable with one particular person and less comfortable with -- and I mean police-type person.
- A Yes. And it becomes an issue especially -- I hate to generalize, but when kids hit their teen years or just before their teen years a lot of times girls won't be as comfortable speaking with me, but they will be much more comfortable speaking with Michelle or Sholeh or another female investigator.
- Q Ms. Allen also asked you was your investigation somewhat unusual. And you said, well, what do you mean by that; and she started asking, well, did you do this or not do that, did you do this or not do that. So your investigation itself, who you interviewed, in your opinion was a fairly typical investigation?
- A I was. I hesitate to use the words "typical" or "unusual" with these cases, because it's -- it's commonly

accepted that all of our cases are going to be really complicated. There tend to be a lot of different relationships involved, a lot of different people involved. So there's no such thing as a typical or usual or unusual case when it comes to juvenile sex abuse.

- Q Okay. Was there something that was very unusual about this case?
 - A I'm not sure I understand that question.
 - Q I'll withdraw the question.

When you -- I'm sorry, my nose is stuffy.

Did you actually speak with Detective Aguiar? Did you email with him?

A I know I spoke with him on the telephone at least once. I do know we corresponded over email, as well, but I wouldn't remember how many times we spoke on the phone versus how many times we emailed.

- Q Okay. And when you were putting in your report the information from him as to why, I mean, was it a brief synopsis, as opposed to every single thing that you and he talked about?
 - A Yes.

- MS. LUZAICH: Thank you.

I would interact with Shabazz and see him around campus, yes, ma'am. 5 0 Okay. 6 MS. LUZAICH: Could he maybe talk a little slower? 7 MS. ALLEN: Me? 8 MS. LUZAICH: No. The witness. A Not really. Shabazz -- when it was at lunch or after school most of the time he would have shades on anyway. You know, I'd see him with shades on, and, you know, just say, what's up, cool dude. But never recall seeing any injuries.

- Q Okay. You also know his sister; is that right?
- 14 A Yes, ma'am.
 - Q Actually which -- which sisters do you know?
 - A I know Victoria, and I've seen his other sister at school, Mahlia [sic] or -- I can't recall her name.
 - Q Mahlica? Does that sound right?
- 19 A Yes.
 - Q Okay. Was either one of those girls your student?
 - A Victoria was on my caseload. As a teacher coordinator in Special Education you're assigned a certain amount of kids to do their educational IEP, which is Individual Educational Plan, to help them to help them succeed academically and socially. So I evaluated her, tested

her, and my interactions with Victoria were more than with anybody else in the family.

Α She also worked as a Special Ed teacher coordinator and taught in Special Education Department at Canyon Springs.

Okay. Do you know -- and this is only if you know, but would Ms. Bywaters have been involved with Victoria?

I think after my first couple years with Victoria being on my caseload she was moved to Ms. Bywaters's caseload.

Okay. All right. Even after Victoria moved did you still have interaction with her?

Α I would see her on campus and, you know, and ask her how things were going and see how she was doing, yes.

All right. Aside from your role as the football coach and Special Ed teacher coordinator what else sort of do you do on campus that maybe it's not part of the curriculum?

I'm pretty much the go-to guy around the campus, kind of a mentor to so many inner-city kids, men, young men, young women, former graduates, graduates, kids that don't have the resources, and we try to get them motivated to use whatever they have as motivation to succeed. Even the principals. And I see kids daily. I'm in the cafeteria, I

get called to classrooms with kids, kids that don't have eyeglasses, kids that don't have dental health or vision, just there's a lot of hats that I wear around there that I've done for so many years that I really enjoy doing.

- Q Is Canyon Springs an at-risk school?
- A It is. It's a Title 1 school and an at-risk school, yes, ma'am.
 - Q All right. I've met with you before; is that right?
- 9 A Yes, ma'am.
- 10 Q And I came to your office?
- 11 A Yeah.

- Q What's unusual about your office, as opposed to some of the other teachers' offices on campus?

 I have things that -- I have school supplies. It's like a
 resource room that I can provide for people that need
 something right now.
- Q All right. So a lot of your students, then, don't have food daily; is that correct?

- 25 A I have Pampers.

So do you provide those to the students, or 1 teachers? 2 3 No, to students that are parents. Okay. And does your school have a higher rate of Q 5 teenage pregnancy? Α Absolutely. All right. You said you remembered Victoria specifically because she was on your caseload; is that correct? Α Yes, ma'am. 10 11 Do you remember the specific years? It was my early years. I want to say maybe between 12 2008 and 2010. 13 All right. Do you remember how she was doing while 14 Q she was in school with you? 15 16 Α Well, just in my evaluation of Victoria she was -- I felt that academically and for her age that she was off task, 17 she was behind. So in my IEPs after testing her with the 18 19 standardized tests that we use I tried to put the 20 modifications and accommodations that she would need to help 21 her. She got it, but it took her different ways and a little longer to get it. So those are the things that I would do. 22 23 Okay. - Q All right. Did Victoria ever come to you and tell you anything that concerned you with regard to her home life?
- A No. She just said that her mother had tough times, you know, because sometimes her attendance would not be -- and I would ask her where was she at. And she didn't have a ride to school or, you know, tough to get to school. She rode the bus. But just, you know, evaluating your students you can kind of tell where they are with my experience, you know, what kind of home life they have.
- Q Okay. What is a mandatory reporter?
- A A mandated reporter Clark County School District in my understanding is if a kid, a student, anybody on campus reports that they feel like they want to cause hurt, harm to themselves or anybody else or something's going on that is causing harm to them, then we go to the counselors or we call Child Protective Services to get it investigated and make a note of it.
 - Q Okay. Have you previously reported what you

perceived to be either abuse or harm to a student or the student harming themselves or something to that -- have you done this? Have you reported someone?

A Yes, ma'am, I have a couple of times at Canyon. Yes, ma'am.

Q Okay. And when would be the last time you did something like that?

A Last time was this past -- beginning of this year. I had a kid that felt like he wanted to cause harm to himself and said he couldn't take it anymore and that he felt like he was going to cause harm to himself. So I immediately contacted Child Protective Services. Never got through, so I did an online report and also went to the school counselors and the Special Ed Department and notified them. We did what we call a protocol.

Q Okay. Had Victoria or any of your students come to you and said, I'm being sexually abused at home, what would you have done?

A Immediately -- I mean, that's not something I would play with. I have two females that I work with. I would have first of all notified them and went directly and filed that report.

Q Okay. And are you -- you're particularly sensitive to that kind of issue; is that correct?

A Any harm, hurt to kids. You know, I have daughters.

You know, I've had a situation before that kind of involved me. And, yes, I would. That's not something I'd take lightly. Okay. You said you had a situation involving you 4 0 before? Yes. 6 Α 7 Okay. And what had happened with that? Well --Α 8 9 MS. LUZAICH: Objection. Relevance. THE COURT: Sustained. 10 BY MS. ALLEN: 11 Okay. Had Victoria or any student come to you and 12 said, I am being like beaten at home, I'm being physically 13 abused at home, what would you have done with that 14 information? 15 16 I would have immediately contacted the Dean's Office 17 and notify the counselors. Okay. So it's the same protocol for sexual abuse, 18 physical abuse? 19 20 Α Any abuse. Okay. Α 19 All right. And I realize that you were probably 20 sent there by Dispatch. 21 Α Correct. 22 Okay. Do you know who had initiated the call for 23 service? 24 Α Not according to this. No, I don't. For sure I do 25 not know who made the phone call.

Q Okay. When you responded to Bally's who did you make contact with?

A I believe we -- according to the report, we made contact with a female who identified herself as Rene Duke, who we further found out was a Tina Rene Duke.

Q All right. And what would be standard protocol for an officer responding to a call for service related to domestic violence?

A First we would -- we would want to establish contact with the victim, the alleged victim. If it was somebody that was claiming any kind of battery, we would offer her some sort of medical response. At that time we would also kind of being looking and evaluating, see if we see any bumps, bruises, scratches, or anything like that.

Q All right. Do you also interview witnesses to the event?

A If they're readily available, yes.

Q Okay. Are you equipped with a camera to take pictures of any injuries if those are available?

A At that time we ourselves, myself and my partner that responded that day, we're enduro officers, which means we rode small off-road bikes. That was our mode of transportation on that day. So we wouldn't have had a camera on us ourselves. We could have called for one if one was necessary.

Understood. Okay. And do you recall whether you or 1 your partner made contact with Ms. Duke? 2 3 Α Yes, we did. Okay. It was both of you? 5 Α Yes, sir. Okay. And during the course of your interaction 6 with Ms. Duke did she describe the details of battery she said she'd suffered at the hands of Frederick Harris? According to the report, she did make note of the 10 incident. Okay. Did she indicate that she'd been slapped 11 12 repeatedly in the face? 13 According to this report, yes, it was. Okay. Did she indicate that a boot had been thrown 14 at her and had hit her in the head? 15 16 Α According to the report, that is the statement that Ms. Duke made. 17 Okay. She also -- well, let me approach, hand you a 18 19 sheet. 20 Okay. Did she indicate any other injuries she 21 believed she sustained from her battery? 22 Other than in the report it says that she was pushed hard and fell back on a table. 23 24 Okay. Did she say that she suffered an injury from 25 that or had sort of soreness, bruising, et cetera? And I'm

asking if she told you that, as opposed to whether you noted it.

A It's been a while, but I don't see anything on here where it says she was in any -- she wasn't reporting any pain at that time, no.

Q Okay. And so as far as you can recall she didn't relate to you that this fall onto the coffee table had injured her back or given her severe bruising to her legs?

A I just -- I want to make clear and I think I need to be clear on something. Myself and Officer Fraley [phonetic] responded to this report. I had a chance to it at it on OnBase, a data system where we scan old documents, and it's there for review. And I don't have those documents with me. However, both of us responded to this. There's two sections to this report. There's a front page with everybody's information, the descriptors, name, date of birth for both parties. There's a second page, which is a narrative, which is the story that's told here.

On this particular incident I reviewed this, and Officer Fraley did the narrative portion of this.

Q Okay.

A At that time I was doing the front page, the documentation of who and what was involved and their descriptors --

Q Excellent.

- -- in addition to preparing to fill out another document, which was a threat assessment which we filled out for this report. So I'm not completely -- I can't completely marry myself to this narrative, because it wasn't written by me. I didn't author this.
- 6 Q Okay. This is your -- this is your partner's 7 report?
 - Α Correct.

Okay. Is it usual where if something's happened at 12 0 13 a house they might point fingers at each other? Oh, yes. 14 Α Okay. In fact, if you find probable cause that a 15 domestic battery has occurred, it's not unusual to make an 16 17 arrest; is that correct? It would be procedure, yes. 18 Okay. And so might you look for injuries consistent 19 with what the victim told you happened? 20 21 Α Absolutely. Might you also look for statements by the alleged 22 perpetrator that corroborate something the victim says? 23 Yes, sir. 24 Α Okay. And that's not unusual at all, is it? 25 0

1 Α No. 2 Okay. Officer, looking at the report there, do you recall whether you made a visual inspection of Ms. Duke's face 3 or her head? 4 My partner noted that there were no bumps or bruises 5 6 on the top of her -- on the top of her head or forearm. 7 There was also a second note by Officer Fraley. Ιt 8 says, "There was no redness or bumps nor bruises on either side of her face." MR. MacARTHUR: All right. Court's indulgence. 10 11 (Pause in the proceedings) 12 BY MR. MacARTHUR: And just one more housekeeping matter, Officer, and 13 14 I'm done with you. 15 I realize that your partner's not here to testify. 16 Do you have any reason not to trust or rely on the representations that he made in that report? 17 No, I don't. 18 MR. MacARTHUR: Okay. Court's indulgence, Your 19 20 Honor. 21 (Pause in the proceedings) 22 BY MR. MacARTHUR: 23 One more thing. There's always one more thing, Officer. And I apologize. 24 25 In making first contact with Tina Duke did she

indicate to you what the fight was about? 1 It states here in the report that apparently she 2 3 hadn't filled out some paperwork to the satisfaction of her boyfriend, Mr. Harris, and that he had gotten physical with her as a result of that. 5 Okay. And had consequently battered her because of 6 Q 7 his dismay? 8 That was her claim, yes, sir. MR. MacARTHUR: Thank you, Officer. I appreciate 9 I have no further questions. 10 THE COURT: Cross-examination? 11 MS. LUZAICH: Thank you. 12 13 CROSS-EXAMINATION BY MS. LUZAICH: 14 Officer Loving, it indicates that you responded to 15 Bally's on October 24 of 2009, somewhere around 10:00 in the 16 17 morning; right? So three and a half days later, because it was 5:00 11 at night and now it's 10:00 in the morning; right? 12 Yes, ma'am. 13 Α And do you -- now, do you recall saying that she had 14 15 told you that when she was at work that day her supervisor 16 encouraged her to report? 17 I seem to recall that, yes. You mentioned that she was given a blue card. 18 19 What's a blue card? 20 Α What we refer to a blue card is it has not only the event number so a victim could refer to the courts for a 21 2.2 protection order. It does give a good number of domestic 23 services, including the contact numbers for the courts to get 24 that restraining order. 25 And that's given all domestic violence situations?

A Yes, ma'am.

Q You mentioned something about a threat assessment. What's a threat assessment?

A Threat assessment was a page that was developed for the Department. There are factors that are involved that shows whether you're really at risk of further violence and even more serious violence. There's questions that are asked on, have you been beaten before, does your -- does the significant other have a gun, are there guns in the home, those kind of questions that would lead somebody to determine you're really at risk here, maybe you shouldn't be staying in the home, that kind of thing.

Q And did you tell her that she shouldn't stay in the home?

A Yes.

Q Did she indicate to you that she was going to go home, she had stuff there?

A She had indicated that she did have things there, and I believe her children were there, that she had children there. We would have told her that if she had felt the need to go ahead and go back that she should go to a location somewhere near the home, call for a police officer to respond with her. She didn't know whether or not Mr. Harris would have been home, so she would have been told, call from an area near the home, wait for a police officer to respond to go back

to that home if you want to collect belongings.

- Q Is that something that you do often in domestic violence situations?
 - A Absolutely.

- Q Now, battery constituting domestic violence, is that a misdemeanor?
 - A It is in this state.
- Q Is that something that you can only arrest if it occurs in your presence?
- 10 A That is not true. Battery domestic violence --
- - A Yeah. Battery domestic is one of those things where if we can substantiate that a battery did occur, it need not have taken place in our presence.
 - Q Okay. Now, since the battery had occurred three and a half days earlier, would it surprise you not to see red marks or things of that nature?
 - A No, it wouldn't surprise me at all.
 - Q And did she also indicate that she fell -- sorry, it's getting harder to read as I get older -- that she fell on her back, landing on a small table, injuring her tailbone?
 - A She did make that claim, yes.
 - Q And did she also indicate that her daughter may or may not have seen the incident because her daughter was in the home?

She did. I have nothing further -- oh. 2 Thank you. 3 I have one more question. Does the report indicate that it was actually 4 assigned to a Domestic Violence detective? 5 6 According to the page, yes, it was. Is there a unit in the Detective Bureau at Metro 7 that does handle specifically domestic violence offenses, they 8 do followup after patrol takes an original report? 9 10 Α That is correct. 11 MS. LUZAICH: Thank you. THE COURT: Any redirect? 12 MR. MacARTHUR: Court's indulgence. 13 (Pause in the proceedings) 14 15 REDIRECT EXAMINATION BY MR. MacARTHUR: 16 Just in followup, Officer, is it your recollection 17 that when she was detailing what had happened to you she was 18 specific in saying that the battery had happened three days 19 beforehand? 20 Is that correct? Α That's what's indicated in the report, yes. 21 Okay. And when people give you that kind of 22 23 information you do your best to detail it in your report; 24 right? 25 Α I believe it is noted in the narrative of that

1 report. Thank you, Officer. 2 MR. MacARTHUR: Excellent. 3 THE COURT: Any recross? MS. LUZAICH: No. 4 THE COURT: Thank you very much for your testimony 5 here today. ALLEN: 9 sure the record's clear, the reason being is that there are -obviously there's corresponding sexual assault under 14 and 16 10 charges, and there's child abuse charges. The child abuse 11 charges are not charged in conjunction with the sexual 12 13 assault. MS. LUZAICH: Also regarding the coercion, which is Instruction Number 21, when I proposed the coercion instruction there was a paragraph that said, "If threats are used, coercion is a felony. If no --" actually, "If force or violence is used, it's a felony. If no force or violence, it's a misdemeanor." The defense specifically indicated that they did not want any lesser instructions, so that part of it was taken out. So the coercion is either going to be a guilty or a not guilty.

Which brings me to page 3 from their instructions.
